## <u>ORIGIN</u>

Staff-initiated report.

## **LEGISLATIVE AUTHORITY**

Police Act, 2004, S.N.S. 2004, c. 31, section 49, states:

49 The board must hold a board meeting at least every three months.

#### RECOMMENDATION

It is recommended that the Board of Police Commissioners for the Halifax Regional Municipality approve the proposed meeting schedule for 2024 as outlined in Attachment 1 of this report.

#### BACKGROUND

The Board of Police Commissioners for the Halifax Regional Municipality (BoPC) currently meets the first Wednesday of each month starting at 4:00 p.m. in person at the HEMDCC Meeting Space, Main Floor Alderney Landing, 60 Alderney Drive, Dartmouth. The BoPC's monthly meetings are currently scheduled for a five hours, with a scheduled end time of 9:00 p.m.

#### DISCUSSION

The recommended meeting schedule provides for nine meetings of the BoPC in 2024 held at the Harbour East Marine Drive meeting space beginning at 1:00 pm. The meetings are scheduled for five hours in duration, with a scheduled end time of 6:00 p.m.

In 2023 a second meeting a month was added for the BoPC. A standard second meeting a month is not recommended at this time. If additional meetings are required, they can be added through motion or called by the chair of the BoPC to address a specific item or issue.

#### FINANCIAL IMPLICATIONS

No financial implications at this time.

#### ALTERNATIVES

The Board of Police Commissioners for the Halifax Regional Municipality could choose to adjust the meeting schedule being recommended to the BoPC.
