# 9.1.1 Case 21402: Sackville Rivers Floodplain Council initiated project to amend the appropriate planning documents to reflect the most recent floodplain mapping for areas surrounding the Sackville and Little Sackville Rivers

The following was before the Committee:

- Initiation Report
- Interactive Map showing existing and updated floodplains
- Sackville Rivers Floodplain Study Phase II (2017)
- Statement of Provincial Interest Regarding Flood Risk Areas

The Chair invited Ben Sivak Principal, Planner, to present Case 21402.

Ben Sivak explained they were seeking the Committee's advice prior to making recommendations to North West Community Council and that the floodplain study was completed in 2017. Reasons for the study were: public safety, protection of personal property, reducing the need for flood control and to reduce cleanup costs/damages after the fact. Climate change is a contributing factor to the increased size of the floodplain. Currently, there is a 5% chance of a 1 in 20 flood event in any given year and there is a 1% chance of a 1 in 100 flood event in any given year. Provincial legislation states that the Municipality must plan for these flood events. High risk flooding areas include the Sunnyside Mall area, Range Park, Sackville Cross Roads and McCabe Lake.

The Committee considered the application with staff responding to questions. Members agreed that this was a good use of funds and questioned whether increasing watercourse buffers and expanding culverts could aid in flood prevention.

Sivak noted they were exploring options to determine the best course of action, and that when permits are issued in the floodplain area, applicants are being referred to the website as well as being advised that the Floodplain Study exists. Currently there are roughly 600-700 properties located within the floodplain area.
