10.1.2 Update on the Body-Worn Camera Pilot Program – Presentations from Halifax Regional Police & Royal Canadian Mounted Police

The following was before the Board of Police Commissioners:

Chief Dan Kinsella, Halifax Regional Police and Inspector Greg Robertson, Halifax Regional Police provided a supplemental report that includes a draft policy framework and research on body-worn video technology and responded to Board questions.

The Board discussed the importance of managing expectations regarding the release of video recordings and privacy considerations, how body-worn video policy will manage accountability when video is not turned on, the impacts of body-worn video on racialized communities and how incidents that are not recorded using body-worn video will be documented.

Jane Fraser, Executive Director of Finance & Asset Management/Chief Financial Officer answered Board questions regarding how the financing of a body-worn video pilot or implementation project would fit into HRM's annual budgeting process.

THAT the Board of Police Commissioners support Body-Worn Video in principal and ask the Chief of Halifax Regional Police to develop the appropriate policies and work plan related to rolling out a program, and come back to the Board with the budget asks for the upcoming 2021-22 budget (for development of a policy and to conduct a Privacy Impact Assessment) and for the 2022-23 budget for potential implementation subject to Capital Budget approval.
