6.1 Committee Discussion of Case 23224 - Former Penhorn Mall Lands

Melissa Eavis, Planner III, Current Planning indicated that there will be a connection made between Penhorn Lake and the Transit terminal along the Circumferential Highway.

The Committee noted that crusher dust is not an ideal material for pathways, as it makes it difficult for wheelchair users and people using mobility aids, pavement would be best. The Committee questioned the standard width of pathways.

David MacIsaac, Active Transportation Supervisor indicated that 4 meters is the standard width and that further updates can be provided to the Committee regarding any amendments to this case.

8.1.1 Staff Update on Projects and Plans

David MacIsaac, Active Transportation Supervisor presented to the Committee and indicated that the full budget has not yet been approved but sections have been taken to Council for consideration. There will be \$3,300,000 added to the budget for this year.

Some projects that will be worked on include new sidewalks on Mount Edward and Flamingo, work on the Dunbrack Greenway, the North Preston project, the Victoria Road project and the multi-use pathway near Cole Harbour Place.

Members noted that more consultation needs to be done with the visually impaired community to ensure designs are safe, accessible and user-friendly. It was also noted that engagement for the Portland Street functional plan is underway and to check the Shape Your City webpage for information with respect to projects.
