# 9.1.1 Tax Relief for Non-Profit Orgs: Proposed Renewal of Tax Relief for Leases Removed from AO 2014-001-ADM Schedules

The following was before the Grants Committee:

He noted that the reason the recommendation is before the Audit and Finance Standing Committee prior to Regional Council is that this matter is outside the parameters of the program and, therefore, is required to go through the Audit and Finance Standing Committee.

#### 9.1.2 BID Contributions Fund: 2017-2018 Recommended Awards

A staff recommendation report dated September 5, 2017.

Peter Greechan provided a brief overview of the BID contributions fund and addressed questions from the Committee.

Councillor Streatch advised that he met with representatives from the Fall River business community this morning and they are looking for assistance in regard to beautification of the business area. The Councillor questioned staff if the group would qualify for this fund.

Peter Greechan responded that they would not qualify for the fund. Peter explained that there are eight business improvement districts that have been approved by Regional Council for the fund. Peter suggested that, if the representatives from Fall River wished to begin the process to become the ninth BID, they could contact staff. Peter cautioned that the process was a significant amount of work.

A brief discussion ensued and it was noted that the North End Business district and the Bayer's Lake business district had been considering this process, and it was suggested that they may be a resource for the representatives of Fall River with regard to the process.
