Patricia Hughes, Manager of Planning and Scheduling, provided a presentation on the 2018/19 First Quarter Halifax Key Performance Indicator Report.

In response to questions from the Transportation Standing Committee, Hughes provided commentary on increases in U-pass ridership, revenue, and general ridership over the first quarter of 2018/19.

Councillor Cleary suggested that the motion be amended to forward the staff information report and presentation to Halifax Regional Council as an information item. The proposed amendment was deemed friendly.

# THAT the Transportation Standing Committee recommends that Halifax Regional Council direct staff to implement routing and peak period service for the Route 415 as described in the approved Moving Forward Together Plan.

Patricia Hughes, Manager of Planning and Scheduling and Erin Blay, Supervisor, Service Design & Projects provided clarification respecting further declines in ridership for the Route 15, and continued levels of service for the community contemplated in Routes 415 and 25.

In response to questions from the Transportation Standing Committee, Hughes and Blay noted that data collected indicates that ridership for the Route 15 increases in the summer and declines in other parts of the year. Hughes advised that this is not enough to sustain the route.

Hughes clarified that the proposed extension of night service for the route 15, contemplated as option B in the August 8, 2018 staff report would likely pose challenges meeting ridership guidelines. Further, Hughes advised that the addition of new service, outside of the Urban Transit Service Boundary in contrary to the Regional Plan.

# 15.1 Councillor Nicoll - Transit Access for Youth

# 15.2 Councillor Zurawski – Transit Changes in District 12

The following was before the Standing Committee:

THAT the Transportation Standing committee ask Halifax Transit staff for:

1. Direction regarding possible short-term solutions in transit routes (in the next few months) issues that residents of District 12 presented to staff at the public open house meeting of Oct 23, 2018 at the Canada Games Centre; and;

2. Prepare a staff report to identify longer term solutions to those constituent concerns regarding the changes in transit routes as identified at the October 23, 2018 meeting and emails and correspondence and 311 requests submitted since the route changes came into effect August 20, 2018.

Councillor Zurawski provided background information respecting concerns raised by constituents at a recent public meeting in District 12 respecting recent changes to transit services that have affected travel time, ability to travel within the municipality, and employment.

Dave Reage, Director of Halifax Transit, offered to meet with the area Councillor to discuss the issues raised by the community and discuss measures to address some of the concerns that have been raised.

The motion was withdrawn with the consent of the Transportation Standing Committee.

## **17. PUBLIC PARTICIPATION**

Anne Gillies of Purcells Cove, provided commentary with respect to the proposed alternative options for the Route 15 bus service in Purcells Cove. Gillies disagreed with the recommendation in the staff report to alter the service noting that it will decrease public transportation access to and from the area, for both residents and visitors. Gillies provided further commentary regarding a lack of time for residents to read and comment on the report and encouraged the Transportation Standing Committee to not support altering the current service.

**Audet Murphy**, of Purcells Cove, spoke in opposition to the alternative options for the Route 15 bus service in Purcells Cove. Murphy advised that from a strategic perspective, altering transit access to Purcells Cove will have a detrimental effect on providing public access to the area, especially to the new wilderness park that will open in 2019. Murphy advised that there is a strong seasonal demand for the Route 15 and it should be considered when contemplating service changes.

**Jeffery Grantham**, of Purcells Cove reiterated points raised by the previous speaker with respect to the restriction of transit service to the area and encouraged the Transportation Standing Committee to maintain the current Route 15 as is. Grantham noted several attractions in the area such as parkland, nature trails, and York Redoubt that could suffer if the current transit access is altered.

**Allan Ruffman**, of Furgesons Cove, provided a historical overview of transit services in the Purcells Cove area advising that there has been a government sanctioned transportation link connecting Purcells Cove to Halifax for the past 119 years. Ruffman advised that bus service has been provided to the area for the past 80 years, both privately and publicly, 48 of which have been provided by the Municipality. Ruffman provided further detail of the historical significance of transit service in the area and noted opposition to the staff recommendation to discontinue the Route 15 bus service. Ruffman concluded by advising that a reduction in transit service will be detrimental to the community as well as the region.

**Sue Molloy**, of Purcells Cove, reiterated the points raised by previous speakers in relation to restricting public access to the area by altering the Route 15 bus service. Molloy provided further commentary regarding the negative impacts that service changes may have on those that are dependent on public transportation.

**Kathleen Paul**, of Purcell's Cove, reiterated points raised by previous speakers in relation to the restriction of public access to Purcells Cove given the proposed alterations to the Route 15 bus service. Paul noted that the staff recommendation will negatively impact low income residents, particularly single mothers. Paul advised that the Transportation Standing Committee consider this when considering the matter.

**Nathan Brett**, of Prucell's Cove, reiterated the points raised by previous speakers respecting the proposed alteration of the Route 15 transit service in Purcells Cove.

**Audet Murphy**, read a letter read on behalf of **Andy MacCallum**, of Ferguson Cove, which spoke in favour of maintaining the current Route 15 bus service as is.

**Linda Christiansen-Ruffman**, of Furgesons Cove, spoke in support of maintain the Route 15 Transit Service in Purcells Cove. Christiansen-Ruffman noted reliance on the bus due to vision loss advising that it is an affordable method of transportation for those that cannot drive. Christiansen-Ruffman noted that many people in Furgesons Cove work outside of peak hours and advised that the restriction of service is very detrimental to the poor and the working poor.

Councillor Outhit called three times for further speakers, there were none present.
