10.3.1 Safety Issues Relating to Signalized Intersection Crosswalks – Martyn Williams and Milena Khazanavicius

Martyn Williams and Milena Khazanavicius gave a presentation on safe signalized intersections noting that currently there is no safety infrastructure to protect vulnerable road users from vehicular traffic at most signalized intersections. Williams sought a road safety audit including driver yield rates, conflict incidences, hazards specific to disabled, senior and child pedestrians, and appropriate countermeasures that meet specific aspects/challenges relating to the different size and designs of intersections in Halifax.
