<b>PROJECT DESCRIPTION</b>	Deterioration of the stone work at City Hall has reached a point where the building envelope is being compromised and public safety around the building is becoming a liability. The project is a systematic, 4 phase restoration of the stone facades of City Hall, beginning with the Argyle St. elevation. Work includes redressing, cleaning, repainting and rebuilding of the sculptured details. Halifax City Hall is located on the corner of Duke and Argyle Streets.
<b>PROJECT BENEFITS</b>	The recapitalization of Halifax's City Hall will extend the useful life of a National Historic Site and make it safe for it's users as well as for tourists who visit the building.
