Terms and Conditions

1. The parking exemption is VALID ONLY WHEN IT IS AFFIXED TO THE UPPER PORTION OF THE FRONT WINDSHIELD ON THE PASSENGER SIDE. VEHICLES PARKED WITHOUT A VALID PERMIT DISPLAYED WILL BE TICKETED.

2. (A) Notwithstanding the provisions of any traffic regulation, the driver or owner of a vehicle in respect of which a Residential Parking Exemption is currently in force is exempt from timed parking and permit restrictions imposed by traffic signs erected by the Traffic Authority:

- i Permitting one hour parking;
- ii Permitting two hour parking;
- iii Prohibiting parking for 30 minutes or an hour in the morning or the afternoon;
- iv Prohibiting parking for 30 minutes or an hour in both morning and afternoon ; or prohibiting parking except by permit
- v

(B) The Residential Parking Exemption is not valid for :

- i Parking meters on a street;
- ii Street cleaning signs;
- iii Winter Parking regulations;
- iv Section 139 of the Motor Vehicle Act R.S.N.S. 1989, c.293 as amended, Respecting impeding snow and ice control regulations;
- v Any other temporary parking controls as established by the Traffic Authority.

3. Residential Parking Exemptions shall not be issued to resident of buildings with more than 4 dwelling units.

4. The applicant agrees that the Halifax Regional Municipality shall not be responsible for damage, loss or theft of any vehicle or property, or for injury to any person, arising out of the parking privileges obtained by this agreement, resulting from any cause whatsoever. The applicant acknowledges that the fee paid to the Halifax Regional Municipality is solely for the privilege of parking.

5. Fees are non-refundable and are not applied on a pro-rata basis.

6. This agreement may be terminated by the Halifax Regional Municipality upon 30 days written notice.

7. Notwithstanding the above, the applicant must comply with By-Law P-1000 "The On-Street Parking Exemption and Permits Bylaw".

8. Subject to the above provisions, the Residential Parking Exemption will expire each 31st day of May.
