**RESPECTING CLOSURE OF A PORTION OF**  
**ROCKY HILL ROAD, HALIFAX**

Whereas Rocky Hill Road, a public street in Halifax Regional Municipality is being altered, improved and redesigned, and as a result thereof part of that street right of way more particularly described in Attachment "A" is proposed to be closed;

And Whereas Rocky Hill Road will remain open to vehicular and pedestrian traffic and will meet all the municipal standards.

And Whereas the Engineer of Halifax Regional Municipality has determined that the portions of the street more particularly described in Attachment "A" are surplus to the needs of Halifax Regional Municipality'


And Whereas the portions of the street more particularly described in Attachment "A" is worth \$6,232 being less than fifty thousand dollars.

And Whereas pursuant to Section 315 (1A) of the *Municipal Government Act* the portions of Rocky Hill Road more particularly described in Attachment "A" may be closed without holding a public hearing

**BE IT RESOLVED AS AN ADMINISTRATIVE ORDER** of Council of the Halifax Regional Municipality pursuant to Section 315 (1) of the Municipal Government Act as follows:

1. A portion of Rocky Hill Road, Parcel A1 and Parcel A2, Halifax, Nova Scotia more particularly described in Attachment "A" is hereby closed.

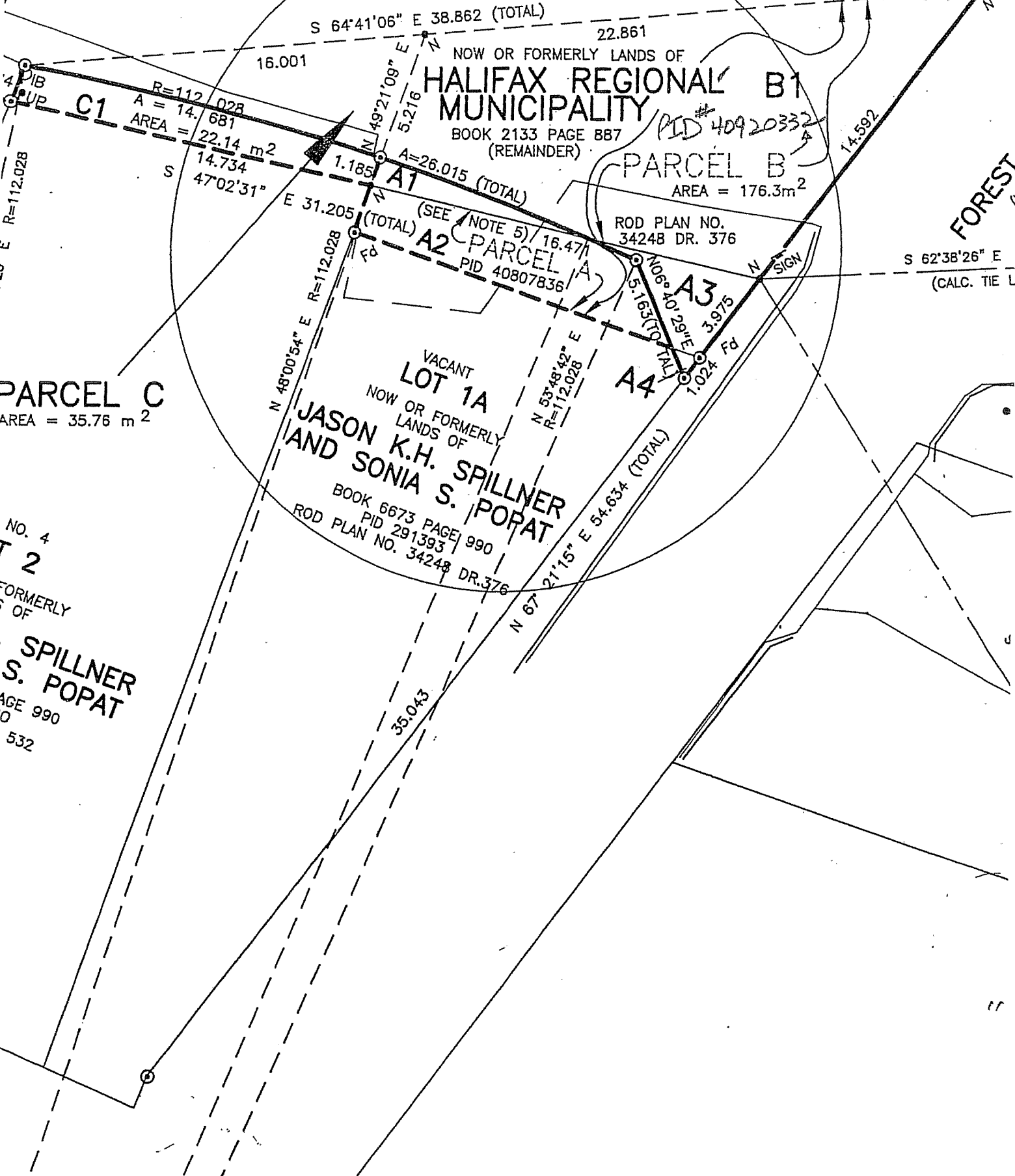
