## **ORIGIN**

It is the practice for the Halifax Peninsula Planning Advisory Committee to adopt a schedule of meetings for the upcoming year.

## **LEGISLATIVE AUTHORITY**

Terms of Reference, Halifax Peninsula Planning Advisory Committee:

The Planning Advisory Committee shall meet at least once per month or as required to conduct business of the Committee. Additional meetings may be scheduled at the discretion of the Chair in consultation with staff.

#### RECOMMENDATION

It is recommended that the Halifax Peninsula Planning Advisory Committee approve the proposed 2019 Meeting Schedule as outlined in the discussion section of this report.

## **BACKGROUND**

In accordance with the Halifax Peninsula Planning Advisory Committee Terms of Reference, the Committee shall meet at least once per month or as required to conduct business of the Committee. The Committee meets the 4th Monday of each month in Halifax Hall, City Hall, 1841 Argyle Street from 4:00 p.m. to 6:00 p.m.

The approval of this schedule will allow members of Council, staff and the public to be notified and plan in advance for meetings. The Chair of the Halifax Peninsula Planning Advisory Committee, with input from staff, has the authority to cancel a scheduled meeting should it be deemed necessary.
