Health, No breach, contravention or failure to comply with these regulations is an offence unless such breach, contravention or failure to comply commences or continues three months after these regulations come

An investigation by our sanitary inspectors reveals that the wells in Africville are heavily contaminated. This is the same condition that recurs each year and efforts are made to warn the people to boil the water or treat it with Javex or some chlorine preparations to provide some degree of safety in its use. The same procedure has followed this year. However, we feel there is little attention given to our warnings and instructions.

We will continue to post warnings on the wells and have brought this to your attention for your information.
