LEGISLATIVE AUTHORITY

Active Transportation Advisory Committee, Terms of Reference:

2. MANDATE

The mandate of the Active Transportation Advisory Committee is to advise the Transportation Standing Committee on all matters relating to active transportation in Halifax Regional Municipality, using the Active Transportation Plan as a guide.

2.1 The committee will provide timely advice to the Transportation Standing Committee on matters relating to budget, infrastructure, education, policy and public awareness.

RECOMMENDATION

THAT the Active Transportation Advisory Committee recommend the Transportation Standing Committee;

- 1. Request the designer present to the Active Transportation Advisory Committee when there is a design available, regarding the intersection where Joseph Howe Drive and the Chain of Lakes Trail meet;
- 2. Urgently request a staff report on, and implementation of, short term safety measures for active transportation until the final project is implemented; and
- 3. The correspondence be emailed to the project designer and the Transportation Standing Committee.
