We have learned that the committee will be receiving a report from staff speaking to a proposal to consider a pilot project on shared mobility; EScooters/micro mobility devices.

While we support any and all initiatives to encourage healthier life styles and sustainable transportation, we are gravely concerned that micro mobility devices, if permitted on a permanent basis will further compromise the independence and safety of vulnerable road users, including pedestrians who are blind.

I believe that this item may come before the committee on February 16. If this is the case, please consider CNIB's request to speak to the committee and share our perspective.
