




Site Map: All Locations




Beaver Bank Rd. and Windgate Dr.



Hammonds Plains Rd. and Pockwock Rd.




Lucasville Rd. and HWY 101

Proposed Amendments

- Development Permits may only be re-issued for existing senior citizens' housing uses until May 23, 2026
- This date is based on the latest permit expiry date -May 23, 2024
- All permit holders get <u>at least</u> 2 additional years beyond standard *HRM Charter* provisions

Implications of Amendments

- *HRM Charter* 12-month deadline removed (Existing Use)
- Deadline to receive a Development Permit: <u>May</u>
 <u>23, 2026</u>
 - Building Permit can be issued within <u>1 year</u> after that (DP expires in 12 months from issuance)
