*****On January 26, 1999, Halifax Regional Municipality Regional Council approved the User Fee Schedule for all HRM owned and operated Outdoor Facilities; on January 11, 2011, Regional Council approved a revised fee schedule for the 2011 Season. By way of that approval, the Facility Scheduling Office was mandated to charge user fees for all scheduled use of outdoor facilities (ie diamonds, sport fields, parks, plazas, special event sites, etc. Therefore, there is no waiving of any fees associated with the scheduling of any and all HRM owned and operated outdoor facilities.*****
