# 9.1.2 Case H00485: Request to Include 2267 Brunswick Street, Halifax in the Registry of Heritage Property for the Halifax Regional Municipality

The following was before the Committee:

- A staff presentation dated January 26, 2022

Jesse Morton, Planner II, gave a presentation and answered questions for the Advisory Committee. Staff advised the Committee that staff's recommendation is to apply the heritage building evaluation criteria to the Committee's heritage assessment.

Following discussion, the Committee decided to apply the heritage building criteria in performing the heritage evaluation and provided the following scoring:

Criterion	Score Awarded
1. Age	13
2. Historical Importance	15
3. Significance of Architect/Builder	6
4A. Architectural Merit: Construction Type	6
4B. Architectural Merit: Style	10
5. Architectural Integrity	9
6. Relationship to Surrounding Area	10
Total	69

The Committee rendered a total score of 69 out of 100 for 2267 Brunswick Street.

THAT the Heritage Advisory Committee recommend that Halifax Regional Council:

1. Set a date for a heritage hearing to consider the inclusion of the subject property in the Registry of Heritage Property for the Halifax Regional Municipality; and

2. Approve the request to include 2267 Brunswick Street, Halifax in the Registry of Heritage Property for the Halifax Regional Municipality, as shown on Map 1 of the December 22, 2021 report, as a municipal heritage property under the Heritage Property Act.

# 9.1.3 Case H00519: Substantial Alteration to the Contributing Heritage Resource at 1266 Barrington Street, Halifax

The following was before the Committee:

- A staff recommendation report dated January 14, 2022
- A staff presentation dated January 26, 2022

Jesse Morton, Planner II, gave a presentation to the Committee. This proposal is to rehabilitate the original inn structure and build a 10-storey rear-yard addition. This building is considered a contributing heritage resource in the Old South HDC. Case 21380, the corresponding planning case is ongoing and will include an assessment using the design manual. Morton reviewed the components of the substantial alterations. Staff's evaluations were shared: impacts on Old South Suburb HDC and impacts on the Waverly Inn, the heritage resource.

Morton confirmed that the building will have wheelchair accessibility. The primary entrance will be in the new section of the inn. Parking will be discussed in the site plan approval application.

The Committee discussed the cupola roof top feature. There was evidence of a previous rooftop feature, but it's exact design cannot be determined. Cupolas are in keeping with the age of the inn. The connection between the inn and the new building was reviewed. The Committee appreciated the copper finishes and cladding tying together the two buildings. The pineapple motif and its connection to the inn was noted as well. Questions were raised about the removal of the rear addition, noting that the addition was part of the transition to an inn originally. The HDC bylaw and plan direct the preservation of character defining elements of the district and the property. In Old South HDC the transition from Georgian to Victorian architectural style is defined. The new addition is proposed to extend the historic use of the property.

Set a public hearing date to consider the proposed substantial alterations to the contributing heritage resource at 1266 Barrington Street, Halifax (the Waverley Inn) as proposed in this report and its attachments, in accordance with By-law H-800 (the Old South Suburb Heritage Conservation District By-law); and

2. Approve the substantial alterations to the contributing heritage resource at 1266 Barrington Street, Halifax (the Waverley Inn) as proposed in the January 14, 2022 report and its attachments, in accordance with By-law H-800 (the Old South Suburb Heritage Conservation District By-law).
