9. REPORTS 9.1 STAFF 9.1.1 Presentation on Accessible Pedestrian Push Buttons – Taso Koutroulakis, Director of Traffic Management

The following was before the Committee:

- A staff recommendation report dated January 12, 2021
- A presentation titled, "Accessible Pedestrian Push-Buttons" dated April 19, 2021

Taso Koutroulakis, Director of Traffic Management presented to the Committee and indicated a staff report went to Transportation Standing Committee on February 25, 2021 containing three recommendations. One being to remove the requirement for the button to be pushed for three seconds to activate the audible tone and allow for single press activation.

Accessible pedestrian signals (APS) assist seeing or hearing-impaired persons cross intersections safely. HRM currently has 338 APS push buttons located at intersections around the Municipality. As of April 9, 2021, all 338 APS buttons have been switched to single press activation.

Other APS related work includes working towards monthly APS button inspections, training sessions with APS vendors/manufacturers and developing an APS maintenance checklist. A copy of the staff presentation is on file.
