# 8.1 Presentation Regarding Potential Amendments to Traffic Calming Administrative Order

The following was before the Standing Committee:

• A staff presentation dated April 15, 2021

Brad Anguish, Executive Director, Transportation & Public Works outlined that the purpose of the presentation was to gather feedback from the Transportation Standing Committee prior to amending and/or replacing the existing Traffic Calming Administrative Order. The purpose of the new Administrative Order is to provide the most significant impact on traffic calming measures within the approved budget.

Jody DeBaie, Transportation and Road Safety Engineer, Traffic Management and Taso Koutroulakis, Manager Traffic Management, answered Standing Committee questions and provided further information. They advised Standing Committee members there would be a neighbourhood approach to traffic calming measures, the scoring system will be based on pedestrian movement, there is ongoing coordination with Planning and Development regarding the adoption of new Red Book (Cross Section Design Manual) requirements, and the existing streets on the list for review will be reviewed in accordance with the new Administrative Order. The intent is to have a draft Administrative Order prepared by Fall 2021.

# 8.2 Pedestrian Infrastructure Highway 101 Exit 2

THAT the Transportation Committee recommend that Halifax Regional Council:

1. Direct the Chief Administrative Officer to conduct functional planning in 2022/23 (pursuant to funding approval in the 2022/23 capital budget) to establish the feasibility of a formal pedestrian crossing from Sackville Manor across Highway 101 based on the considerations outlined in the Discussion section of the staff report dated March 22, 2021; and,

2. Direct the Chief Administrative Officer to initiate conversation with NSTIR to request that they install measures (e.g. jersey barriers, fencing) to serve as a deterrent to pedestrian crossing between Sackville Manor and Old Sackville Road as an interim measure.

Siobhan Witherbee, Active Transportation Planner, Transportation and Public Works, provided an overview regarding the proposed construction of pedestrian infrastructure at Highway 101 Exit 2.

Witherbee and Philip Nickerson, Design Engineer, Transportation and Public Works, responded to Standing Committee questions.

Councillor Russell requested that part 2 of the motion be amended to read "consider installing" measures.

As set out in Section53 (2) of Administrative Order One, Respecting the Procedures of the Council, this change to the motion was accepted as friendly.
