10.1 PUBLIC HEARINGS

10.1.1 Case 21927: Amending Development Agreement for 1490 Main Road, Eastern Passage

The following was before Community Council:

A staff recommendation report dated October 10, 2018

Dean MacDougall, Planner II presented the application by Garmar Investment Ltd. to amend an existing development agreement to allow for the subdivision and development 1490 Main Road, Eastern Passage through the as-of-right process. The original planning application for the subject site considered the subdivision of a portion of the lands subject to the as-of-right provisions of the Regional Subdivision Bylaw (RSBL) and Eastern Passage/Cow Bay Land se By-law. An administrative error made at the final stages included the remaining lands within the development agreement thereby removing any development rights. A copy of the presentation is on file.

MacDougall responded to questions respecting the administrative error.

The Chair opened the public hearing and invited the applicant to come forward and address Council.

Gary Edwards, President of Garmar Investments Ltd. explained that when they started the process, planning staff had suggested the development agreement be done before the subdivision of lands, and how the error was discovered when they made their application for subdivision.

The Chair reviewed the rules of procedure for public hearings and called for anyone wishing to speak on the matter.

Terry Morash, Eastern Passage did not oppose the amendment but sought information on future development rights for their property.

Councillor Austin called three times for any further speakers, there were none.

Councillor Austin invited the Applicant to respond to points raised during the public hearing. The Applicant did not make any further comments.

THAT the public hearing be closed.

11.3 Presentations

11.3.1 Margo Riebe-Butt, Executive Director, Nourish Nova Scotia re: advocacy work within the community, and how municipalities in other jurisdictions support school food programs and initiatives

Margo Riebe-Butt, Registered Dietitian and Executive Director, Nourish Nova Scotia spoke to their advocacy work for a universal healthy school food program and food literacy initiatives, and how the Halifax Regional Municipality and other municipalities can support these programs and initiatives. Members were asked to join the Campaign by:

- signing Petition E-1957 seeking Federal investment to implement an adequately-funded national cost-shared universal healthy school food program
- showing support for #SpeakUp4SchoolFood

Riebe-Butt responded to questions, speaking further to the Food and Nutrition Policy for Nova Scotia Public Schools launched in September 2006, and the National School Food Program resolution adopted by the Federation of Canadian Municipalities (FCM) March 2018. It was noted that the scope of programming and how well the provincial policy is implemented depends on the school's capacity. Members discussed ways to support school food programs.
