Mr. Ray Ritcey, Chair of the Halifax Water Board of Commissioners provided introductions. Mr. Carl Yates, General Manager, Halifax Water presented the third year of Halifax Water's five year business plan approved by the Halifax Water Board in October, 2014. Mr. Yates explained that based on favourable operational results over the last two years there are no rate applications planned for this year, which was approved by the Halifax Water Board February 2, 2017.

Halifax Water staff responded to questions on their Integrated Resource Plan to renew aging water, wastewater and stormwater infrastructure, achieve compliance with new federal wastewater regulations and facilitate growth. Staff also responded to questions on water fluoridation, explaining that they fluoridate the water as an industry best practice based on direction provided by the Nova Scotia Chief Medical Officer of Health, the Centre for Disease Control and Prevention (CDC), and the Canadian Dental Association.

Whereas Halifax Regional Municipality has an interest in pursuing alternative propulsion technologies for Halifax Transit buses;

Whereas a consensus is forming across Canada on the need to reduce GHG emissions through new technologies;

Whereas emissions from the transportation are the second highest sector within Canada; Whereas Canadian transit manufacturers are currently researching, developing and deploying new electric transit technologies that will offer significant emissions reductions; Whereas costs for these new technologies are still out of reach for many Canadian municipalities, due in part to their slow rate of adoption across Canada;

Whereas a leading factor in the slow adoption of electric transit technologies is the lack of technological harmonization across municipalities and between transit manufacturers.

THEREFORE, IT IS RESOLVED THAT THIS COUNCIL:

Declare that it will pursue a coherent and sustained procurement process with regards to electric bus charging technologies that is harmonized with other municipalities across Canada.

Request other municipalities join in this harmonization, with the goal of more quickly commercializing electric transit technologies, increasing their adoption and reducing urban GHG emissions in the transportation sector.

Urge transit manufacturers to create a Canadian standard.

# 11.1 Case 20405: Amendments to the Halifax MPS and Halifax Peninsula LUB for Halifax Grammar School, 915, 921, 945, and 967 Tower Road, Halifax

The following was before Council:

Ms. Leah Perrin, Planner 1 provided the staff presentation on the application by the Halifax Grammar School to amend the Municipal Planning Strategy for Halifax (MPS) and the Land Use By-law for Halifax Peninsula to permit an expansion to the Tower Road campus of the Halifax Grammar School.

Mayor Savage opened the public hearing and invited the applicant to come forward and address Council.

Mr. Steven Laffoley, Headmaster of Halifax Grammar School addressed Council and advised that for 60 years Halifax Grammar School has been a presence in Halifax and been a good neighbour within the area. He explained that the project will enable them to pursue aspirations and provide improved assets such as a gym, theater and teaching areas to the broader community while protecting the original Tower Road School. He added that there is overwhelming support in the community for their proposal, and then introduced Joe Zareski, the architect for the project. Mr. Zareski continued the presentation elaborating on the design and amenities of the project.

Mayor Savage reviewed the rules of procedure for public hearings and invited members of the public to come forward to address Council at this time.

Mr. Michael Lee, Fall River, addressed Council speaking in support of the application. Mr. Lee advised that his daughter attends the Grammar School and it has been a tremendously positive influence in her life. In addition, Mr. Lee pointed out that, as a professor at Dalhousie University he regularly has students in his class who attended the Grammar School and he finds that the education they received at the Grammar School makes them stand out among their peers.

Ms. Maureen Reid addressed Council and advised that her daughter was a grade 8 student at the Grammar School and has been attending the school since primary. Ms. Reid noted the long standing reputation for excellence the school has had and that the small size of the school has enabled her daughter to partake in various sports and arts programs. She advised that the proposal will consolidate the campus to one site and provide new and different types of learning spaces for the students as well as enhanced gym and arts spaces. She urged Council to support the application.

Mr. David Wilson, Chairman of the Board of Governors of Halifax Grammar School addressed Council highlighting the role the Grammar School has played in the community and he requested Council's support of the project.
