Both staff and some members of Council expressed concern with risks around liability, accessibility and setting precedence having residents clear municipal sidewalks.

Matt Keliher, Manager of Solid Waste Management presented the recommendations for the Organics Management Strategy and key terms for the Request for Qualifications (RFQ). Keliher highlighted the results of the public and stakeholder survey and responded to questions about moving forward with the RFQ and Request for Proposal (RFP) in relation to reducing/eliminating odor through state-of-the-art odor management technology. Keliher spoke about the new composting standards in Nova Scotia adopted in 2010, explaining that Nova Scotia Environment did not provide a timeline or instruct the Municipality to bring the current composting facilities to the 2010 standard. Keliher confirmed that there would be no windrow composting at the expanded facility/facilities.

Councillor Streatch rejoined the meeting during deliberations of the motion.

Council recessed at 12:03 p.m. with a note being made that discussion of Item 14.1.11 would continue following the Heritage Hearings scheduled for 1:00 p.m.

Matthew Keliher, Manager of Solid Waste, responded to questions of clarification, noting:

- Staff recommends against introducing grass to the compost program based on concerns regarding leachate, nitrogen content, grass-cycling and minimizing processing costs;
- The proposed RFQ would allow operators to propose both aerobic and anaerobic options for Council's consideration; and
- The RFQ provides risk mitigation strategies for a smooth transition between contractors.

THAT the motion be amended to add "grass" to Section 9, paragraph 2 of Attachment A to the staff report dated March 2, 2017.
