The following does not represent a verbatim record of the proceedings of this meeting.

The meeting was called to order at 9:36 a.m., and recessed at 12:00 p.m. Budget Committee reconvened in at 1:00 p.m. and recessed at 2:45 p.m. Budget Committee reconvened at 3:01 p.m. and adjourned at 4:28 p.m.

1. CALL TO ORDER

Councillor Karsten, Chair called the meeting to order at 9:36 a.m. in Council Chamber, 3rd Floor City Hall, 1841 Argyle Street, Halifax.

2. APPROVAL OF THE MINUTES - NONE

Kevin Arjoon, Municipal Clerk advised that if funding for the Navigator Suburban/Rural Pilot is approved during the 2019/20 Budget Adjustment List, Item No. 3 will be presented to Regional Council at a future date.

3. 2019/20 Budget Adjustment List for Consideration

- i) Public Participation
- ii) Debate

The following was before Budget Committee of the Whole:

- A staff recommendation report dated February 15, 2019
- A handout entitled "Budget Adjustment List Summary"
- A handout entitled "Reserve History Projected to March 31, 2019"
- A handout entitled "Tax-Supported Debt"

Councillor Karsten invited members of the public to address the Budget Committee on the 2019/2020 Budget.

Robert Grant, of the Urban Developers Institute of Halifax provided commentary respecting potential increases to regional development charges for new development in HRM. Grant advised that increased development charges can cause consequences respecting the costs of development and could have an adverse effect on housing affordability.

Kevin Russell, of the Investment Property Owners Association of Nova Scotia (IPOANS) provided commentary proposing the removal of the residential rental sector from the Industrial, Commercial and Institutional (ICI) sector for solid waste removal. Russell noted that 38 percent of the population in Halifax rent and that property managers are forced to rely on third party contractors for solid waste removal which comes at a cost to tenants. Russell concluded by advising that expanding HRM's solid waste services to the residential rental sector would assist in actioning HRM's affordable housing initiatives.

Brenden Meagher, President of the Halifax Professional Fire Fighters, provided commentary on the proposed Budget for Fire Services in HRM. Marr advised that the Fire Service runs effectively and efficiently on a lean budget and encouraged members of Council to support the parking lot items for Fire Services to ensure quality service for HRM residents.

Councillor Karsten called three times for further speakers; there were none present.

Jane Fraser, Chief Financial Officer noted the following changes to the Budget Adjustment List (BAL):

- Item No.16 the deferred implementation of the fee renewal for Parks and Recreation has been removed due to Council direction provided on February 26, 2019.
- Item No. 18a. proposed funding for grass and shrub contract increases will be moved out to 2020/2021 budget year.

In response to a follow up question, Fraser provided commentary with respect to third quarter projections which places the surplus at \$3.6 million, after the proposed \$11.6 million in other project commitments.

The Budget Committee agreed by consensus to vote separately on each operating over budget item outlined in the February 15, 2019 staff report.

MOVED by Councillor Nicoll, seconded by Councillor Whitman

THAT the Budget Committee direct the CAO to finalize the 2019/20 Proposed Budget and Business Plans as previously directed, including:

- i) A \$600,000 reduction in the 2019/20 Fiscal Services budget;
- ii) The use of an additional \$600,000 from the projected 2018/19 Halifax Transit budget surplus as a one-time change to fund costs of the Moving Forward Transit Plan, and:
- iii) any additional changes adopted by the Committee from the Budget Adjustment List.

MOVED by Councillor Austin, seconded by Councillor Whitman

THAT the Budget Committee amend the Budget Adjustment List to deal with proposed adjustments involving external groups last.

MOTION PUT AND PASSED.

Articled Clerk Program - Legal, Municipal Clerk and External Affairs

MOVED by Councillor Nicoll, seconded by Councillor Whitman

THAT the Budget Committee direct staff to prepare the 2019/2020 budget with the addition of \$113, 900 for the Articled Clerk Program.

MOTION PUT AND PASSED.

New Full Time Employee - Legal Assistant - Legal, Municipal Clerk and External Affairs

MOVED by Councillor Nicoll, seconded by Councillor Whitman

THAT the Budget Committee direct staff to prepare the 2019/20 budget with the addition of a new full-time employee – Legal Assistant at \$54,300.

MOTION PUT AND DEFEATED.

New Full Time Employee – Administrative Assistant (GREA) – Legal, Municipal Clerk and External Affairs

MOVED by Councillor Nicoll, seconded by Councillor Whitman

THAT the Budget Committee direct staff to prepare the 2019/20 budget with the addition of a new full-time employee – Administrative Assistant (GREA) at \$76,700.

MOTION PUT AND PASED.

Development of Social Policy Lens and Public Safety Goals - Legal, Municipal Clerk and External Affairs

MOVED by Councillor Nicoll, seconded by Councillor Whitman

THAT the Budget Committee direct staff to prepare the 2019/20 budget with the addition of \$40,000 to develop a social policy lens and public safety goals with community partners.

MOTION PUT AND PASSED.

New Full Time Employee - Conflict Resolution/Respectful Workplace Specialist - Human Resources

MOVED by Councillor Nicoll, seconded by Councillor Whitman

THAT the Budget Committee direct staff to prepare the 2019/20 budget with the addition of a new full-time employee – Conflict Resolution/Respectful Workplace Specialist at \$100,000.

MOTION PUT AND PASSED.

Senior Snow Program - Continue Service and Right Size Budget - Transportation and Public Works

MOVED by Councillor Nicoll, seconded by Councillor Whitman

THAT the Budget Committee direct staff to prepare the 2019/2020 budget with the addition of \$100,000 to continue and right-size the budget for the Senior Snow program.

MOTION PUT AND PASSED.

Tree Planting/Pruning – Urban Forests Master Plan – Transportation and Public Works

MOVED by Councillor Nicoll, seconded by Councillor Whitman

THAT the Budget Committee direct staff to prepare the 2019/2020 budget with the addition of \$400,000 for tree planning and pruning associated with the Urban Forest Master Plan.

The following amendment was proposed:

MOVED by Councillor Mason, seconded by Mayor Savage

THAT the Tree Planting/Pruning program be reduced to \$200,000 from \$400,000 for 2019/2020.

In response to a follow up question, Brad Anguish, Director of Transportation and Public Works advised that sufficient resources will be in place to continue with the inoculation of emerald ash species in HRM.

THAT the Budget Committee direct staff to prepare the 2019/2020 budget with the addition of \$679,000 for expected service changes associated with Group B – Moving Forward Together Plan.

MOVED by Councillor Hendsbee, seconded by Councillor Outhit

THAT Budget Committee request a supplementary staff report on raising the fare of Transit from \$2.75 to \$3.00.

Paving of Sucker Brook Road - Transportation and Public Works/Capital

THAT the Budget Committee direct staff to prepare the 2019/2020 budget with the addition of \$37,000 to pave Sucker Brook Road, Lower Sackville.

MOTION PUT AND DEFEATED.

North American Indigenous Games Facilitate HRM's commitment to the 2020 games

Denise Schofield, Director of Parks and Recreation provided clarification on the funding partnership between the Federal, Provincial and Municipal Governments noting that HRM's commitment of \$500,000 to be funded from the Marketing Levy Special Event Reserve.

In response to a question from the Budget Committee, Jane Fraser advised that the funding is reported as an over commitment as staff requires permission to access the reserve funds, pending receipt of an application from the event hosts.

THAT the Budget Committee request a supplemental staff report regarding the North American Indigenous Games funding and business plan to be presented to Regional Council.

THAT the Budget Committee direct staff to prepare the 2019/2020 budget with the addition of \$60,000 for Canada Union of Public Employees (CUPE) position conversion.

Arts Halifax Funding Enable increased support to Arts organizations - Parks and Recreation

THAT the Budget Committee direct staff to prepare the 2019/2020 budget with the addition of \$150,000 in funding for Arts Halifax to enable increased support for arts organizations.

The following amendment was proposed:

THAT the proposed funding commitment for Arts Halifax be reduced to \$75,000. AMENDED MOTION PUT AND PASSED.

THAT the Budget Committee direct staff to prepare the 2019/2020 budget with the addition of \$75,000 in funding for Arts Halifax to enable increased support for arts organizations.

THAT the Budget Committee direct staff to prepare the 2019/2020 budget with the addition of two permanent Planner II positions at \$180,000.

THAT the funding commitment be reduced to \$90,000 for one permanent Planner II position.

In response to follow up question, Kelly Denty, Director of Planning and Development clarified that the positions will be funded on an ongoing basis though anticipated revenue collected from development fees

The amendment was withdrawn by the mover. The question was called on the main motion.

Regional Planning: 2 Permanent Planner III positions – Planning and Development

THAT the Budget Committee direct staff to prepare the 2019/2020 budget with the addition of 2 permanent Planner III positions at \$192,000.

<u>Director's Office: 1 Term Report Controller position – Planning and Development</u>

MOVED by Councillor Nicoll, seconded by Councillor Whitman

THAT the Budget Committee direct staff to prepare the 2019/2020 budget with the addition of One Term Report Controller position at \$80,000.

MOTION PUT AND PASSED.

<u>Infrastructure Planning: 1 Permanent Transportation Demand Management Coordinator position – Planning and Development</u>

MOVED by Councillor Nicoll, seconded by Councillor Whitman

THAT the Budget Committee direct staff to prepare the 2019/2020 budget with the addition of one permanent Transportation Demand Management Coordinator position at \$100,000.

MOTION PUT AND PASSSED.

<u>Buildings & Compliance: 7 Term Compliance Officer I positions + 1Term Supervisor (Parking Enforcement) – Planning and Development</u>

MOVED by Councillor Nicoll, seconded by Councillor Whitman

THAT the Budget Committee direct staff to prepare the 2019/2020 budget with the addition of seven term Compliance Officer 1 positions (parking enforcement) at \$596,000.

MOTION PUT AND PASSED.

<u>Buildings & Compliance: 2 Term Compliance Officer II positions (Other Enforcement)</u>

MOVED by Councillor Nicoll, seconded by Councillor Whitman

THAT the Budget Committee direct staff to prepare the 2019/2020 budget with the addition of two Term Compliance Officer II positions (other enforcement) at \$159,000.

Water Quality Monitoring Program - Planning and Development

THAT the Budget Committee direct staff to prepare the 2019/2020 budget with the addition \$150,000 for a Water Quality Monitoring Program.

Rural Transit Funding - Planning and Development

THAT the Budget Committee direct staff to prepare the 2019/2020 budget with the addition of \$220,000 for Rural Transit programming.

Accessible Taxi Trip Supplement - Planning and Development

MOVED by Councillor Nicoll, seconded by Councillor Whitman

THAT the proposed accessible taxi trip supplement be removed for consideration until 2020/2021 to complete ongoing work on the file.

Navigator Program - Legal, Municipal Clerk and External Affairs

MOVED by Councillor Nicoll, seconded by Councillor Whitman

THAT the Budget Committee direct staff to prepare the 2019/2020 budget with the addition of \$90,000 for the Navigator Program.

In response to a question from Budget Committee, Maggie MacDonald, Managing Director of Government Relations and External Affairs advised that the proposed funding for the navigator program is to study and address homelessness throughout HRM.

MOTION PUT AND PASSED.

Reduction of 4-8 Full Time Staff Positions – Halifax Public Libraries

MOVED by Councillor Nicoll, seconded by Councillor Whitman

THAT the Budget Committee direct staff to prepare the 2019/2020 budget with the addition of \$350,000 for four to eight full time staff positions for Halifax Public Libraries.

Program Funding to Enhance Food Literacy – Halifax Public Libraries

THAT the Budget Committee direct staff to prepare the 2019/2020 budget with the addition of \$50,000 to enhance food literacy programming at Halifax Public Libraries.

Program funding directed at reducing isolation within the community – Halifax Public Libraries

THAT the Budget Committee direct staff to prepare the 2019/2020 budget with the addition of \$50,000 for programming related to reducing isolation within the communities.

<u>Station 45 (Fall River) additional 10 firefighters to increase service delivery to 24/7 from E Platoon – Halifax Regional Fire and Emergency Services</u>

THAT the Budget Committee direct staff to prepare the 2019/2020 budget with the addition of \$363,000 for ten additional firefighters for Station 45-Fall river to increase service delivery.

Reverse reductions to services as required to meet 1.9% target – Halifax Regional Fire and Emergency Services

MOVED by Councillor Nicoll, seconded by Councillor Whitman

THAT the Budget Committee direct staff to prepare the 2019/2020 budget with the addition of \$997,000 to reverse proposed reductions to services as required to meet the 1.9% target.

Option "B" of volunteer record checks - Halifax Regional Police/HRM Fiscal Services

MOVED by Councillor Nicoll, seconded by Councillor Whitman

THAT the Budget Committee direct staff to prepare the 2019/2020 budget with the addition of \$200,000 for option "B" for volunteer record checks.

MOTION PUT AND DEFEATED.

One-time capital contribution in the amount of \$1,000,000 to the YMCA of Greater Halifax/Dartmouth towards the purchase of a replacement YMCA facility

MOVED by Councillor Nicoll, seconded by Councillor Whitman

THAT the Budget Committee direct staff to prepare the 2019/2020 budget with the addition of \$1,000,000 for a one-time capital contribution to the YMCA of Greater Halifax/Dartmouth for the purchase of a replacement YMCA facility.

In response to questions from Budget Committee, Schofield advised that the project is under construction, and the contribution from HRM would assist with the Capital campaign. If the request is not approved, the YMCA will have identified other revenue sources through its capital campaign.

In response to follow up questions, Schofield provided clarification on initiatives offered by the YMCA to assist those with limited or lower means with access to recreation programming.

MOTION PUT AND PASSED.

ICT - Partnership with VOLTA Labs- Finance and ICT

MOVED by Councillor Nicoll, seconded by Councillor Whitman

THAT the Budget Committee direct staff to prepare the 2019/2020 budget with the addition of \$250,000 to establish a partnership with VOLTA Labs and HRM.

MOVED by Mayor Savage, seconded by Councillor Nicoll

THAT the funding commitment be reduced to \$125,000.

In response to a follow up question, Sarah Teal, Chief Information Officer, provided clarification on the proposed project work with VOLTA advising of opportunities to leverage and move data from a smart cities perspective and to allow students and interns to be exposed to the VOLTA environment.

MOTION TO AMEND PUT AND PASSED.

The motion before Budget Committee now reads:

THAT the Budget Committee direct staff to prepare the 2019/2020 budget with the addition of \$125,000 to establish a partnership with VOLTA Labs and HRM.

In response to a follow up question, Fraser advised that an additional \$1.9 million from the projected surplus would be required to reduce the tax rate to 1.9%.
