The meeting was called to order at 9:34 a.m., and recessed at 12:00 p.m. Budget Committee reconvened in at 1:05 p.m. Budget Committee adjourned at 1:32 p.m.

### 1. CALL TO ORDER

The Chair called the meeting to order at 9:34 a.m.

### 2. APPROVAL OF THE MINUTES - NONE

### **3. PUBLIC PARTICIPATION**

The Chair called for members of the public to come forward.

**Michael MacFadden**, representing the Halifax Regional Trails Association, spoke to Council in support of more investment in nature to realize healthier lifestyles, greater diversity and make Halifax a great place to visit and the place of choice to live. They noted that \$500,000 earmarked for parkland acquisition is less than provided in previous years and will not be sufficient to realize the Halifax Green Network Plan which passed with unanimous Council support. They requested that Council invest more in green space acquisition and in maintenance of acquired greenspace.

The Chair called three times for further speakers and there were none.

### 4. Parks and Recreation

At the January 29, 2020 Budget Committee meeting, Denise Schofield, Director, Parks & Recreation, delivered a presentation on the Parks and Recreation 2020/21 Budget and Business Plan.

The following motion was put on the floor at the January 29, 2020 Budget Committee meeting.

# THAT the Budget Committee direct the Chief Administrative Officer to prepare the Parks & Recreation 2020/21 Budget and Business Plan, incorporating Regional Council's fiscal direction as per the January 7, 2020 Budget Committee meeting and as proposed in the accompanying presentation, and furthermore to prepare Over and Under items for that Plan as directed by Regional Council's Committee of the Whole on Budget.

Budget Committee discussed the motion with staff responding to questions. Schofield clarified that in terms of potential parking lot items, the Committee can consider both options over and under budget and pressures within the budget but that the Committee has also been provided, for information, with a list of requests that would be coming before Council for consideration in the coming months.

# THAT the Budget Committee include a reduction of \$50,000 relating to Right of Way mowing (Council approved areas from 2011/2012 report) to the proposed 2020/21 budget for Parks and Recreation to the parking lot as an operating under budget option for consideration.

The Budget Committee requested a list of areas to be affected by the proposed mowing reduction.

In response to a question from the Committee, Schofield advised that should Council approve the reduction in right of way mowing, a communications strategy will be formulated to advise residents of the change.

Schofield informed the Committee about the challenges experienced in recruiting staff for the Inclusion Program as many of the programs are not continuous and only take place over the summer period. Schofield advised that the staffing expansion will increase the number of Inclusion Program staff, undertaking recruiting, training and working with parents and partners, from one to three.

Schofield advised the Committee that a fee review is underway and staff will be recommending to Council that the additional lighting fees charge, over and above the outdoor facilities rental cost, be discontinued.

THAT the Budget Committee request a supplementary staff report regarding increasing the budget for trail maintenance by \$79,000 as an operating over budget option for consideration in the parking lot.

Angela Green, Manager, Recreation Programming explained that the aquatic instructional program is very popular and qualified instructors are required and that the salary adjustment is proposed as an incentive as the lifeguard and instructor positions are paid at the same level while the instructor positions involve more responsibility.
