The meeting was called to order at 10:00 a.m. and adjourned at 10:12 a.m.

1. CALL TO ORDER

The Chair called the meeting to order at 10:00 a.m.

2. APPROVAL OF THE MINUTES - January 15 and 22, 2020

3. PUBLIC PARTICIPATION

The Chair called for members of the public to come forward.

Colin May, Dartmouth, spoke to the draft Regional Police 2020/21 Budget and noted that page 5 of the Budget indicates that the Chief Administrative Officer has direct oversight of all business units, including the Halifax Regional Police. May noted that the Police Act does not give the Chief Administrative Officer this power and opined that clarification may be required to ascertain whether the Chief of Police reports to the Board of Police Commissioners or to the Chief Administrative Officer. May remarked that Halifax is the only major city in Canada where the Chief Administrative Officer is involved in the affairs of its Police Department. May also spoke to the sale of Saint Patrick's High School which they noted has been posted on the Property Valuation Services Corporation (PVSC) website and wondered why no public announcement has been made regarding the sale. May remarked that the PVSC site also has posts relating to recently disposed-off apartment buildings and noted that the likely result of the sales would be increased rent for residents. May noted that there is a growing housing crisis and urged Regional Council and the Province to address the issue.

The Chair called three times for further speakers and there were none.
