13.3.1 Province of Nova Scotia QEII Master Plan

The following was before Council:

John O'Connor, Executive Director of Major Infrastructure Projects, Nova Scotia Department of Transportation and Infrastructure Renewal, provided a presentation on the QEII Master Plan and outlined the various components of the project including an expanded inpatient building, a new research, innovation, and learning centre, a new cancer centre, a new outpatient centre, a new parking structure, and a new heating plant.

Jacques Dubé, Chief Administrative Officer, noted that HRM is currently working alongside the Province of Nova Scotia (PNS) to come to a mutually agreed upon development plan for the QEII New Generation Project.

Council raised several concerns, namely that the entire final plan including the full scope of all changes should come forward to Council for public consultation. O'Connor clarified that the current plan will be released to the public and that there are no additional plans other than what has been already presented.

Council was also concerned with the proposed parking structure at the Victoria General Hospital (VGH) as well as the encroachment to extend a parking garage across Summer Street toward Abbie J. Lane. O'Connor clarified that there is no plan to build a parking structure at the VGH, however confirmed that the PNS did request encroachment to build a parkade across Summer Street.
