#### 7.1.1 QEII Redevelopment Project and Associated HRM Property Transactions

THAT Halifax Regional Council authorize the Chief Administrative Officer to:

1. Negotiate and enter into an Encroachment Agreement for an elevated pedway across Summer Street, based on the key terms and conditions set out in Table 1 of the staff report dated April 3, 2020; and

2. Grant an easement upon municipal parkland between the lands of the provincial Nova Scotia Museum and Bell Road, as outlined and identified in Attachment 1 of the staff report dated April 3, 2020, subject to the acceptance of a traffic assessment, and other studies as may be required, by the Municipal Engineer, and the retention of the functionality of municipal parkland as outlined in the staff report dated April 3, 2020.

Jacques Dubé, Chief Administrative Officer, provided an overview of the QEII Redevelopment Project and Associated HRM Property Transactions as outlined in the April 3, 2020 staff report.

In response to questions from Council, Dubé noted that the existing parking lot located at the east of the property will remain in place for the time being. Dubé advised that discussions with the province are ongoing regarding the future use of this land as the redevelopment project progresses.

With respect to traffic flow, pedestrian and active transportation safety, Kelly Denty, Director of Planning and Development advised that the Municipal Land-use regulations do not apply to provincial land. However, Denty advised that staff are anticipating a high-quality design in terms of traffic flow, active transportation and pedestrian safety.

Council discussed the importance of continued cooperation with the Province to ensure a high-quality design of the QEII redevelopment that is in keeping with established urban design principals.
