6.1 Administrative Order 50, Disposal of Surplus Property – PID 41079807, 4 Fernhill Drive, Dartmouth - Supplementary Report*

THAT Halifax Regional Council:

Amend the permitted intended use as set out in the terms and conditions of the conveyance of 4 Fernhill Drive, Dartmouth, Nova Scotia (currently identified as PID 41079807) to be for the delivery of Lake City Employment Services Association's programs and services for adults living with mental illness:
- 2. Amend the terms and conditions of the conveyance of the said property situated at 4 Fernhill Drive, Dartmouth, to remove the requirement to consolidate it with Lake City Employment Services Association's existing land, and instead to require the said Association to enter a Buy-Back Agreement; and
- 3. Release Lake City Employment Services Association from the Buy-Back Agreement dated June

7, 2001, applied to the previous conveyance of lands identified as PID 40522096 and a Portion of PID 00063354 Windmill Road, Dartmouth, Nova Scotia.

8.1.1 Award - 20-100 for the Purchase of One (1) New Mid Mount, 100' Aerial Apparatus

THAT Halifax Regional Council award Tender 20-100 for the purchase of one (1) new mid mount, 100' aerial apparatus to Mic Mac Fire for \$1,854,744 (net HST included) with funding from Project Account No. CE180002 - Fire Fleet Replacement, (to be changed to CE200002 in 2020/21) as outlined in the Financial Implications section of the staff report dated March 17, 2020.

Chief Stuebing, Halifax Regional Fire and Emergency Services and Jerry Blackwood, Director of Corporate and Customer Services responded to questions regarding the tendering process and the bid competitiveness.

THAT Halifax Regional Council award the design and construction of a protected bike lane along a portion of Lower Water Street fronting the Queens Marque development to the Armour Group Ltd. in the amount of \$225,619.84 (net HST included) with funding from Capital Budget CR200007 – Regional Centre AAA Bikeways as outlined in the Financial Implications section of the staff report dated March 13, 2020, pending approval of the 2020/21 Capital Budget.

8.1.3 Municipal and CSAP Elections - Election Methods and Alternative Voting Dates

The following was before Council:

THAT Halifax Regional Council:

- 1. Adopt Option 1 as outlined in Attachment A of the staff report dated March 19, 2020 and direct: (a) that use of a telephone and a personal computing device as the only method of voting to be used in the 2020 Municipal and CSAP Elections during alternative polling days, including during the advance polls; and
- (b) that paper ballot be used as the only method of voting on ordinary polling day.
- 2. Set the dates for alternative voting to commence on Tuesday, October 6, 2020 at 8:00 a.m. and run continuously through to Wednesday, October 14, 2020 at 7:00 p.m.

In response to questions from Council, John Traves, Municipal Solicitor advised that some segments of the public are unable to vote electronically. Traves noted that if it is not possible to conduct a paper ballot vote due to public health requirements than staff would be able to conduct an all electronic vote.

- 2. Set the dates for alternative voting to commence on Tuesday, October 6, 2020 at 8:00 a.m. and run continuously through to Wednesday, October 14, 2020 at 7:00 p.m.
- 3. Request a supplementary staff report regarding options to increase the number of polling locations in all electoral districts, increase the number of in-person electronic and paper voting locations per district from one to three during advanced polling aligning with federal and provincial locations.

8.1.4 Proposed Amendments to Administrative Order 14, Respecting the Application of Interest Charges on Outstanding Accounts and Administrative Order 18, Respecting Revenue Collections Policy - Property Tax Deferral and Financial Relief Measures in Response to COVID-19

The following was before Council:

- A staff presentation dated April 14, 2020

MOVED by Deputy Mayor Blackburn, seconded by Councillor Whitman

THAT Halifax Regional Council adopt the amendments to Administrative Order 14, Respecting the Application of Interest Charges on Outstanding Accounts, and Administrative Order 18, the Revenue Collections Policy Administrative Order, as set out in Attachment 3 of the staff report dated April 2, 2020.

Jane Fraser, Chief Financial Officer provided a presentation on the proposed amendments to Administrative Orders 14 and 18.

In response to questions from Council, Fraser advised that staff are in contact with banks respecting property tax payments and mortgage deferrals.

Fraser provided further clarification with respect to the proposed tax deferral and reduced interest rates including the impact on taxpayers who are currently in arrears.

The following amendment to the motion was proposed:

MOVED by Councillor Whitman, seconded by Councillor Outhit

THAT the motion be amended to lower the interest rate from 15% to 5% for a period of six (6) months.

Fraser advised of a potential shortfall of approximately \$1.5 million in revenue with the proposed interest rate reduction.

Jacques Dubé, Chief Administrative Officer advised that staff will be coming forward to Council with more financial options by the end of May during the budget presentation and suggested that taking further action to reduce interest rates at the present time may be premature. Dubé encouraged Council to defer a

decision on further interest rate reductions until staff can bring back more options for Council on how to deal with financial challenges resulting from the COVID-19 pandemic.

In response to a follow up question, Fraser advised that if approved, tax bills will be due on June 1, 2020 and no interest will be charged for the month of May.

Fraser advised that if the staff recommendation is approved, a public service announcement and communications campaign will follow to advise residents of the changes.

In response to a follow up question Fraser further advised that staff will be deferring tax sales and that a report is forthcoming to Council on this matter.

In response to a follow up question, Dubé provided an overview of the proposed communications strategy on the deferral of property taxes and other COVID-19 financial relief measures. Dubé further noted that all communications will clearly note that this an interim measure until Council considers the updated Budget in May.

Fraser concluded by advising of savings related to gas and diesel prices, recreation programming, and reductions in employee travel and conference attendance.
