4. 2021 - 2025 Strategic Priority Framework and Multi-Year Strategic Planning and Budget Process

The following was before Budget Committee:

- A staff presentation entitled 2021-2025 Multi-Year Strategic Planning Framework and Planning Process
- Correspondence from Katherine Sircom, Wendy McDonald, and Maggy Burns

Jacques Dubé, Chief Administrative Officer, and Jane Fraser, Director of Finance & Asset Management/CFO, provided an overview of the Strategic Priority Framework and Multi-Year Strategic Planning and Budget Process.

Wendy Lines, Manager of Corporate Planning, gave a presentation to the Budget Committee and answered questions for Councillors. Regarding "Prosperous Economy" priority issues, Council discussed the possibility of the inclusion of language to emphasise the importance of local growth as an essential but non-exclusive aspect of a prosperous economy.

Council proposed including wording emphasising the importance of affordable housing as a priority issue. Council suggested "demonstrating leadership and fostering partnerships that provide access to a full range of quality, affordable housing options in safe and vibrant neighborhoods." There were no objections from Council regarding the inclusion of this language and the proposed wording. Staff confirmed the proposed wording would be adopted into the Strategic Priorities Plan as a Strategic Priority Outcome under "Communities". They further confirmed that staff plans to return to Budget Committee on January 12, 2021 with individual initiatives to advance higher strategic priories based on feedback from this meeting as well as the budget survey.

- 3. Approve the discontinuation of the Budget Allocator tool in favour of Online Business Planning and Budget Survey;
- 4. Approve the 2021/22 Committee of the Whole Business Planning and Budget Meeting Schedule (Attachment B of the staff report dated November 18, 2020.)
