The meeting was called to order on February 17, 2021 at 9:38 a.m., and recessed at 11:58 a.m. Budget Committee moved into an In Camera (In Private) session at 1:00 p.m. and reconvened to public session at 1:48 p.m. Budget Committee recessed on February 17, 2021 at 3:48 p.m., reconvened on February 19, 2021 at 9:31 a.m. and adjourned at 11:22 a.m.

The Chair called the meeting to order at 9:38 a.m. on February 17, 2021

# 4. PUBLIC PARTICIPATION

Harry Critchley, Halifax, Co-Chair of the East Coast Prison Justice Society spoke before the Budget Committee regarding the proposed Halifax Regional Police 2021/22 Budget. Critchley expressed a desire that Halifax Regional Police (HRP) be held accountable for completion of Wortley Report recommendations when the Budget Committee considers HRP's budget requests. Critchley also spoke regarding their concerns about the use of polygraph testing by HRP and the funding of victim services.

**Tari Ajadi, Halifax,** Board member of East Coast Prison Justice Society and the Nova Scotia Policing Policy Working Group spoke before the Budget Committee regarding their concerns about the proposed body worn camera pilot project. Ajadi expressed concerns about increasing HRP's budget when the Board of Police Commissioners and Regional Council are researching the definition of defunding the police. Ajadi also expressed concerns regarding the results of the Auditor General's IT security audit and requested that the Budget Committee reject HRP's budget request.
