1. CALL TO ORDER

The Chair called the meeting to order at 9:33 a.m. on March 24, 2021.

2. APPROVAL OF THE MINUTES - March 3 and 10, 2021

3. CALL FOR DECLARATION OF CONFLICT OF INTERESTS - NONE

4. PUBLIC PARTICIPATION

Curtis Larsh, a resident of Halifax, spoke before the Budget Committee regarding the need for greater pedestrian safety infrastructure. Larsh requested that Budget Committee consider the adoption of inclusive language reflecting the experience of pedestrians and "strollers" (an inclusive term intended to represent persons of all ages and abilities). Larsh stated that 383 strollers have been struck by vehicles this year and asked that Budget Committee members bear these victims in mind in making decisions regarding pedestrian safety and infrastructure.

Shalom Mandaville, a resident of Dartmouth, spoke before the Budget Committee requesting that Transportation and Public Works consider the adoption of dedicated water treatment plans for areas adjacent to municipal highways, mainly in high-density areas. Mandaville stated that street cleaning will not adequately remove microparticles including metals such as copper and zinc, posing a risk to lakes and watercourses.

Andrew Philopoulos, Manager of Solid Waste Resources, confirmed that twelve events are currently planned and included in the proposed budget.
