12.2 Case 22670 - MPS and LUB Amendments to Allow for Industrial and Highway Commercial Uses on the Conrad Quarry Lands, Montague Gold Mines and Waverley

First Reading was given on January 11, 2022.

Tyson Simms, Planner III, gave a presentation on Case 22670 and responded to questions of clarification from Regional Council.

The hearing opened at 6:49 p.m.

Mayor Savage reviewed the rules of procedure for public hearings and noted that the Halifax Regional Municipality was the applicant for this hearing.

Mayor Savage called for anyone wishing to speak on the matter.

Kim Conrad, Conrad Quarry Property Owner, spoke to the measures that their company has undertaken since 1965 on this site which included a water management plan that is updated to maintain relevancy, public engagement through open houses, and taking weekly water samples.

Greg Zwicker, Zwicker and Zareski Architecture and Planning, spoke to the ongoing conversation between Regional Council and the property owner over the past eight years, and thanked Council for their consideration.

Mayor Savage called three times for any other members of the public wishing to speak on the matter, there were none present.

Tyson Simms, Planner III, responded to questions of clarification from Regional Council regarding previous conversations with the property owner where they indicated they would be comfortable with this amendment.
