### 11. PUBLIC HEARINGS

11.1 Case 19514 - Amendments to the Halifax Municipal Planning Strategy (MPS) and Mainland Halifax Land Use By-law (LUB) and associated Development Agreements for the former Motherhouse Lands, Bedford Highway, Halifax (Joint Public Hearing with Halifax and West Community Council)

The following was before Council:

Ben Sivak, Principal Planner, Planning and Development, provided Council with a presentation on Case 19514 Seton Ridge Neighbourhood Plan, outlining the proposal by Southwest Properties and Shannex Incorporated to develop a new high density, mixed-use neighbourhood on the former Motherhouse Lands.

Responding to questions from members of Council, Sivak noted that the development is anticipated to accommodate a population of approximately seven thousand (7,000) people. They further noted that there is currently no specific requirement for affordable housing units in the proposed development.

Mayor Savage opened the public hearing and invited the applicant(s) to come forward and address Council.

**Jim Spatz**, Executive Chairman, Southwest Properties, provided Council with a presentation on Case 19514 Seton Ridge Neighbourhood Plan, outlining their proposal to develop a new high density, mixed-use neighbourhood on the former Motherhouse Lands.

Responding to questions from members of Council, Spatz noted that while there is not a municipal requirement for affordable housing units set out in the proposed development, Southwest Properties is committed to making five percent (5%) of the units affordable housing; the rent for which would match provincial and municipal standards. Spatz further noted that the heated pavement system will only be used for steep grades in excess of twelve percent (12%).

**David Harrison**, on behalf of Jason Shannon, President and Chief Operating Officer of Shannex Incorporated, provided Council with a presentation on Case 19514 Seton Ridge Neighbourhood Plan, outlining Shannex's role in the proposal to develop a new high density, mixed-use neighbourhood on the former Motherhouse Lands.

Mayor Savage reviewed the rules of procedure for public hearings and called for anyone wishing to speak on the matter.

**David Hopkin**, Halifax, identified a number of concerns with the proposed development. They noted that the green buffer-zone that was initially proposed has significantly decreased. It was indicated at prior information sessions on the development that the population for the development would be in the range of three thousand (3,000) to four thousand (4,000), rather than the seven thousand (7,000) that is now being proposed. They noted that affordable housing does not appear in the proposed development agreement, and expressed concerns about the development's impact on local waste water infrastructure. Hopkin requested that Council consider directing staff to prepare a supplementary report to look further into some of these concerns.

**Brian Jessop**, Mount Saint Vincent University, spoke about the development and the design process that they have gone through with the developers. They noted that they have worked closely with the developers. Jessop went on to note that the development will make the area more bike-friendly, and will help address traffic safety concerns for the University. The development will also provide greater opportunities for housing and employment for students and faculty.

**Joan Okeefe**, speaking on behalf of the Sister's of Charity, noted that they have worked closely with the developers and support the proposal before Council.

**Lilani** Kumaranayake, Chartwell Lake, Halifax, noted that members of the surrounding community were only given short notice of the changes in the prorposed development. They noted concerns with high population density, which would be much greater than surrounding neighbourhoods. They expressed concern about the impact of this high density on transit, local traffic, and waste water management. Kumaranayake also expressed opposition to the plan to cut down the majority of the existing forest growth. Speaking to the proposed heated pavement system, they expressed concern that it would be the Municipality and tax payers who would be responsible for covering heating costs in the future. Kumaranayake requested that Council consider requesting a supplementary staff report to look further into some of these issues.

**Roger Stein**, Canary Crescent, Halifax, expressed concern about the population density of the proposed development, specifically noting the traffic congestion that may result in an area that already experiences issues with traffic congestion. They also expressed opposition to the plan to cut down the majority of the existing forest growth.

**Faith Buchanan**, Bridgeview, Halifax, requested that Council consider requesting a supplementary staff report to look further into some of the issues identified by members of the community. They expressed concern with the plan to cut down the majority of the old growth forest and the impact on the local environment. They noted concerns with potential flooding on the Bedford Highway, as well as increased traffic congestion. Buchanan expressed concern about potential damage the development with cause to supporting community buildings and private residences.

**Morris Nantin**, Canary Crescent, Halifax, noted that they share the same concerns as expressed by other members of the community regarding the proposed development. Nantin noted their concern with the proposed height restrictions being much higher than surrounding dwellings. They also expressed concern about the impact on local traffic congestion.

**Matthew Boudreau**, Bayview Road, Halifax, questioned whether the proposed bike lanes would be a viable, well-used addition to local infrastructure. Boudreau also noted their concerns about the impact of blasting on surrounding properties during the construction of the proposed development.

**Tanya Boudreau**, Bayview Road, Halifax, noted concerns that new traffic lights on Seton Road and the Bedford Highway would create stop-and-go traffic; adding to the congestions issues already being experienced. They also expressed concern about the impact of blasting on surrounding properties during the construction of the proposed development.

**Allan Ruffman,** Fergusons Cove Road, Halifax, noted that the population density of the proposed development would be much greater than the surrounding communities. They noted that this will add to the existing traffic congestion problems along the Bedford Highway.

The Mayor called three times for any other speakers. There being none, it was MOVED by Councillor Mancini, seconded by Councillor Cleary

THAT the public hearing be closed.

THAT Halifax Regional Council approve the proposed amendments to the Halifax Municipal Planning Strategy (MPS) and Mainland Halifax Land-Use By-law (LUB), as set out in Attachments A and B of the staff report dated June 1, 2018, to allow the development of a mixed-use community on the former Motherhouse lands in Halifax.

Responding to further questions of clarification, Sivak noted that should Regional Council approve the proposed amendments to the Halifax Municipal Planning Strategy, then the matter would go back before Halifax and West Community Council, and members would have an opportunity to ask questions and suggest changes to the proposed development agreement to address any community concerns. They further noted that the Municipality would be responsible for the care and maintenance of the new roads in the proposed development agreement after a period of seven (7) years.

# 11.2 Case H00445 - Schmidtville Heritage Conservation District Plan, Heritage Conservation District By-law H-700, and Amendments to the Halifax Municipal Planning Strategy and the Land Use By-law for Halifax Peninsula

- Applicant presentation from the Friends of Schmidtville
- Correspondence from Paul Pittson, Ian Nason, Joseph Arab and Benjamin Carr, and Ted MacLean

Seamus McGreal, Planner III, provided Council with a presentation on Heritage Conservation Districts and Case H00445; Schmidtville Heritage Conservation District Plan, Heritage Conservation District Bylaw H-700, and Amendments to the Halifax Municipal Planning Strategy and the Land Use By-law for Halifax Peninsula.

Responding to questions from members of Council, McGreal noted that the proposed amendments would eliminate the gross floor area ratio (GFAR) and gross lot coverage requirements for properties in the area; allowing for greater flexibility for property owners wishing to build additions to the back of their lots. Such development in the Schmidtville neighbourhood would require the additional step of receiving a certificate of appropriateness from a Heritage Officer. McGreal further noted that under the current Land Use Bylaw (LUB), a minimum of 2000 sq ft is required to subdivide and build on lots in the area.

Mayor Savage opened the public hearing and invited the applicant to come forward and address Council.

**Larry Haiven**, Friends of Schmidtville, provided Council with a presentation on Case H00445; Schmidtville Heritage Conservation District Plan, Heritage Conservation District By-law H-700, and Amendments to the Halifax Municipal Planning Strategy and the Land Use By-law for Halifax Peninsula. The presentation outlined the history of the Schmidtville neighbourhood and the role that the Friends of Schmidtville have played in bringing the current proposal forward.

Mayor Savage reviewed the rules of procedure for public hearings and called for anyone wishing to speak on the matter.

**Lyndon Watkins**, Schmidtville, Halifax, spoke in support of the proposed Heritage Conservation District, noting the historical importance of Schmidtville to the Municipality. They highlighted the unique Georgian and Victorian architecture of the neighbourhood. Watkins noted that the proposal before Council is a good balance between the competing interests of preserving heritage and development.

**Christine Macy**, Dean of Faculty of Architecture and Planning, Dalhousie University, spoke on behalf of Dalhousie University to express concern about the impact of the proposal on the future development of Dalhousie University campus buildings bordering the Schmidtville neighbourhood. Specifically, they noted their concern that Dalhousie will be limited in their future plans to develop the Sexton Campus under Policy 10 of the Schmidtville Heritage Conservation District Plan. They request that Council affirm that development on the Sexton Campus is government by the framework of the Downtown Plan.

**Nathan Rogers**, Assistant Director of Capital Planning at Dalhousie University, noted that Policy 10 is concerning to Dalhousie because it intends to limit the height of street walls along Queens Street to reflect the character of Schmidtville. This potentially limits the future redevelopment of the Sexton Campus, and creates significant uncertainty for their future planning. They requested that Council direct staff to amend or remove Policy 10 from the Schmidtville Heritage Conversation District Plan.

**Barb Webber**, Schmidtville, Halifax, noted that Schmidtville is an accessible and livable community that needs to be protected. They noted that the heritage of Schmidtville is a major draw for tourists to the area.

**Peter Salinger**, Schmidtville, Halifax, expressed concern that Dalhousie University is bringing their concerns to Council at this late stage in the approval process for the Schmidtville Heritage Conservation District Plan, despite numerous public information sessions held over the years.

**William Breckenridge**, Schmidtville, Halifax, spoke in support of the proposed Heritage Conservation District, noting that it is needed to protect the remaining neighbourhood. They noted that the current plan has been developed over a number of years and reflects an approach that balances both protecting heritage and development. Breckenridge noted that it is also an example of what needs to happen with other historic neighbourhoods within the Municipality.

**Allan Ruffman**, Fergusons Cove Road, Halifax, stated that the ten (10) years that it took to implement the Barrington Heritage Conservation District was too long and the Schmidtville Heritage Conservation District should not be subject to the same delays. They suggested that the Municipality seek amendments to the *Halifax Charter* that would allow for the Municipality to declare a moratorium on demolitions when engaged in such heritage planning processes. Ruffman expressed the view that Policy 10 should not be removed from the Plan to accommodate Dalhousie.

**Laura Cousson**, Schmidtville, Halifax, spoke in support of the Schmidtville Heritage Conservation District Plan, noting the importance of protecting this historically significant community in Halifax.

**Jane Gordon**, Schmidtville, Halifax, noted that through their work as a volunteer cruise ship greeter at Pier 21, they have seen that many tourists are interested in seeing the heritage of Halifax, with Schmidtville in particular being a big draw. They asked that Council take action to ensure that this heritage is protected.

**Ted Maclean**, Schmidtville, Halifax, noted that they are owners of a through-lot property in Schmidtville. MacLean noted that the gross floor area ratio (GFAR) requirement that was implemented in the area reduced the development potential of their property, and expressed concern that the new Heritage District Conservation Plan may continue to limit their development potential. They requested that Council look to apply s. 289 of the *Halifax Charter* to allow for development of lots in the area that are ten percent (10%) under the minimum 2000 sq ft. They also expressed concern that the maps for the Plan indicate that some of the properties are subject to a thirty-five (35) ft height restriction, while others are subject to a twenty-five (25) ft height restriction. MacLean requested that their property be changed to the twenty-five (25) ft height restriction. They noted that the purpose of the request is so that they may be able to subdivide their property and build an additional dwelling in the future.

**Blair Beed**, Summit Street, Halifax, spoke in support of the Schmidtville Heritage Conservation District Plan, noting that they have provided walking tours of the area for tourists for over forty-five (45) years. They noted the historical significance of the Schmidtville neighbourhood and that it is an asset to the Municipality that needs to be protected.

**David Griese**, Schmidtville, Halifax, noted that with the main NSLC Cannabis store opening in Schmidtville, it is likely to become a much more prominent area in Halifax. On this basis, they noted that the Municipality should ensure that it is a protected and attractive neighbourhood.

The Mayor called three times for any other speakers. There being none, the Mayor invited the applicant to come forward again to address Council.

**Larry Haiven**, Friends of Schmidtville, noted that they have never been approached by Dalhousie in an official capacity about the Heritage Conservation District Plan. This is despite numerous public information meetings and engagements seeking input which have taken place over a number of years.

MOVED by Councillor Nicoll, seconded by Deptuy Mayor Mason

THAT the public hearing be closed.

THAT Halifax Regional Council adopt the amendments to the Municipal Planning Strategy for Halifax and the Land Use By-law for Halifax Peninsula, as contained in Attachment C of the staff report dated March 6, 2018 and Attachment D of the supplementary staff report dated May 24, 2018, and the Schmidtville Heritage Conservation District Plan and the Schmidtville Heritage Conservation District By-law (H-700) as contained in Attachments A and B of the staff report dated March 6, 2018.

Responding to questions from members of Council, McGreal noted that Policy 10 arose from the background study for the Schmidtville Heritage Conservation District Plan that identified appropriate development around the periphery of Schmidtville. The intent of the study was to look at reducing the height of street walls to better reflect the character of the neighborhood. Municipal staff had consulted with Dalhousie early on in the process and Policy 10 was amended from its original text to "consider at a later date," recognizing that it is outside the boundaries of the proposed Schmidtville Heritage Conservation District.

McGreal further noted that the minimum square footage to create a subdivision on a through-lot in the area is 2000 sq ft. Reducing the requirement to 1800 sq ft would allow for additional properties in the neighborhood to be able to subdivide, but it would be precedent setting in terms of minimum square footage requirements under the Land Use Bylaw (LUB).

McGreal advised that staff would be in support of making the change requested by Ted McClain from the thirty-five (35) ft height limit to a twenty-five (25) ft high limit on the property in question.

Responding to questions from Council, John Traves, Municipal Solicitor, noted that removing Policy 10 from the Schmidtville Heritage Conservation District Plan would not be a substantive amendment, and thus, would not trigger the need for further public hearings.

MOVED by Councillor Smith, seconded Councillor Cleary

# THAT the motion be amended to remove Policy 10 from the Schmidtville Heritage Conservation District Plan.

Responding to questions from Council, Aaron Murnaghan, Principle Planner, noted that staff's position is that the inclusion of Policy 10 is good planning policy and reflective of the wishes of the community. It gives Council the opportunity in the future to consider what an appropriate street wall height would be along Queen Street taking into account the existence of the Schmidtville Heritage Conservation District.

Councillor Smith and Councillor Cleary agreed to withdraw the motion to amend.

Councillor Smith requested that planning staff commit to work with Dalhousie University to address this matter in the future should any issues arise with respect to future developments.

MOVED by Deputy Mayor Mason, seconded by Councillor Whitman

# THAT the motion be amended to include the following:

"That section 70I (10) of the By-law to Amend the Halifax Peninsula Land Use By-law to Implement the Schmidtville Heritage Conservation District Plan as set out in Attachment D of the supplementary staff report dated May 24, 2018, be amended so that:

- 1. The minimum lot frontage under 70l(10)(b) be reduced from 20 feet to 18 feet; and
- 2. The minimum lot area under 70l(10)(d) be reduced from 2,000 square feet to 1,800 square feet.

That section 70I (10) of the By-law to Amend the Halifax Peninsula Land Use By-law to Implement the Schmidtville Heritage Conservation District Plan as set out in Attachment D of the supplementary staff report dated May 24, 2018, be amended so that:

- 1. The minimum lot frontage under 70l(10)(b) be reduced from 20 feet to 18 feet; and
- 2. The minimum lot area under 70I(10)(d) be reduced from 2,000 square feet to 1,800 square feet.

### 11.3 Less than Market Value Sale - Conservation Easement, Purcell's Cove Backlands

The following was before Council:

- A staff recommendation report dated July 11, 2018
- Staff presentation titled "Proposed Shaw Wilderness Park"
- Correspondence from Philip Howard, Dusan Soudek and Stephen Drage

Richard Harvey, Manager Policy & Planning, Parks & Recreation, provided Council with a presentation on the proposed conservation easement and less than market value sale of Purcell's Cove Backlands to the Nature Conservancy of Canada.

Mayor Savage reviewed the rules of procedure for public hearings and called for anyone wishing to speak on the matter.

**Kathleen Hull**, Purcell's Cove resident, Executive Officer of the Williams Lake Conservation Company, and Co-Chair of the Backlands Coalition, spoke in support of the proposed conservation easement. They noted that development on these lands would seriously compromise the local environment and the beauty of the surroundings, including the two (2) lakes. Hull requested that Council pass the motion as presented.

**Robin White**, President of Williams Lake Conservation Company, noted that their company is very much in support of the proposed conservation easement and less than market value sale. They noted that Williams Lake is currently suffering from the effects of environmental pollution. The only source of fresh water to rejuvenate the lake comes from the Backlands, and if they are protected, then there is a chance that the Lake can recover.

**Allan Ruffman,** Ferrgusons Cove Road, Halifax, spoke in favour of the proposed conversation easement and less than market sale of the property.

Janet Morris, Halifax, noted that they own property on Purcells Cove Road adjacent to the Backlands. They noted that they are in support of the parkland proposal. However, they pointed out a narrow strip of land on the Northeast side of the property that they do not wish to see become part of the parklands due to the privacy concerns of adjacent properties. Morris further noted that the stream on this narrow strip acts as a natural fire barrier and should be protected from public use. They requested that Council modify the terms and conditions for the acquisition of the lands and the sale of the conservation easement to reflect the concerns of the adjacent property owners.

The Mayor called three times for any other speakers. There being none, it was MOVED by Councillor Karsten, seconded by Deputy Mayor Mason

THAT the public hearing be closed.

### **THAT Halifax Regional Council:**

- 1. Approve the sale of a conservation easement, respecting the lands to be acquired by Halifax Regional Municipality from Clayton Developments Limited (located adjacent to Williams Lakes in Halifax and identified on Map 1 of the staff report dated July 11, 2018), to the Nature Conservancy of Canada for \$2,500,000, a less than market value sale, subject to the terms and conditions of Regional Council's Motion of September 5, 2017;
- 2. Authorize the Mayor and the Municipal Clerk, on the advice of the Chief Administrative Officer, to enter into:
  - a) an agreement of purchase and sale with Clayton Developments Limited to acquire the lands, and:
  - an agreement of purchase and sale with the Nature Conservancy of Canada to sell the conservation easement across that portion of the lands excluding the parking area and trailhead; and
  - a Conservation Easement Agreement with the Nature Conservancy of Canada, if in the opinion of the Chief Administrative Officer, they meet the terms and conditions of Regional Council's Motion of September 5, 2017; and
- 3. Direct staff to include sufficient funds in the 2019/20 Operating Budget for park maintenance costs.
