| The objective of this report is to bring HRM into alignment with conventional practice for street sweeping in other North American and European municipality surveyed (Toronto, Vancouver, Montreal, Winnipeg, Ottawa, Boston, New York City, Washington, Chicago, Oxford UK, Cambridge UK, London).   |  |                               |   |                        |  |
| December 8th staff report suggested that moving to alternate side parking might be confusing and difficult to comply with. It's important to note that alternate side parking has not been a problem or source of confusion in any other jurisdiction. (i.e., with the exception of St. John, NB, Halifax is unique in its practice of conducting non-emergency municipal operations at night in residential neighborhoods.) |  |                               |   |                        |  |
| December 8th staff report suggested that two additional sweepers would potentially be required if program is moved to daytime hours. Council requests that staff consider reducing frequency of operation in neighborhoods currently being serviced most every week during the months May through November.
