# RECOMMENDATION

The Heritage Advisory Committee recommends that the Community Planning and Economic Development Standing Committee request a review to improve time frames for any future Heritage Conservation Districts after the completion of Schmidtville Heritage Conservation District.

## BACKGROUND/DISCUSSION

The Heritage Advisory Committee held a discussion at the November 22, 2017 meeting, with regard to length of time it has taken to complete the Old South Suburb and Schmidtville Heritage Conservation Districts. Both Heritage Conservation Districts were initiated in 2015.

Heritage Planning staff discussed the challenges encountered with the creation of the Heritage Conservation Districts, and efforts that are being made to move them forward. Staff advised that following completion, a review of the timeframe and lessons learned will be undertaken to make improvements to the process for future Heritage Conservation Districts.

Following discussion, the following motion was approved by the Committee:

That the Heritage Advisory Committee recommend that the Community Planning and Economic Development Standing Committee request a review to improve time frames for any future Heritage Conservation Districts after the completion of Schmidtville Heritage Conservation District.
