Taking action

- ☐ The Joint Project Regulatory Modernization is underway to reduce regulatory burden and red tape for business
- ☐ The collaboration includes:
 - Province of Nova Scotia
 - Halifax Regional Municipality
 - Halifax Partnership
 - Halifax Chamber of Commerce
 - Canadian Federation of Independent Business
 - Urban Development Institute
 - Spring Garden Road Business Association
 - Restaurants Canada
- An all-hands-on-deck approach is needed within government and outside of it. The Joint Project will deliver short-term, tangible results.

Better regulation - better results

- ☐ Regulation is a powerful public policy tool that supports efficient and effective markets, protects consumers, workers, and the health, safety and environment for citizens and communities
- ☐ Alternatively, unnecessary, overly complex, outdated, and duplicated regulation can distort markets, and burden citizens, businesses and governments it doesn't always get the job done
- ☐ Regulatory reform is a powerful lever for economic growth and creates the conditions for increased business productivity and innovation
- ☐ Modernizing regulation and related business processes reduces the undue burden of regulation making it easier to do business in Halifax

The problem with red-tape

- Red tape imposes real-time and systemic costs to business and government and impacts economic viability and community prosperity
- The costs and impacts are often not well understood or measured
- ☐ Businesses are negatively impacted by overly complex or over-reaching regulations, lengthy approval processes, and lack of access to timely information
- ☐ Regulations that don't achieve policy outcomes efficiently or effectively bog regulators down and can impede market innovation and productivity
- Regulation is typically the default solution but its not always the best tool to solve the problem

Taking action

- ☐ The Joint Project partners are working on an action plan to reduce the burden of red tape
- ☐ From simple regulatory amendments to more efficient admin processes and customer service, this targeted approach to regulatory modernization will create a more business-friendly environment
- Actions of the Joint Project include:
 - adoption of Governing Principles for Regulation to help regulators gather clear evidence that regulation is, in fact, the best tool to achieve the policy objective
 - □ adoption of a tool to calculate the costs of proposed regulation to business using tangible measures of time and dollars
 - ☐ making specific short-term changes that will simplify regulation, streamline approval processes, and make it easier for business to comply
 - setting up processes for the Halifax Regional Municipality to work with the Province in delivering the NS Business Navigator Service

Taking action

- ☐ The Joint Project will help leverage a continuous improvement approach to red tape reduction by building a stronger business lens for decision-making including:
 - consistent efforts to streamline and coordinate regulations and approvals
 - the goal of imposing the minimum impact needed to achieve policy objectives
 - customer service targeted to the needs of the business client
 - design of regulations and rules that are easy to understand and comply with
 - developing clear outcomes and measures of regulatory performance
 - ☐ a higher sense of urgency for regulatory administration to meet the realtime realities of doing business
 - continuous development of tools and resources to support administrators who are working toward performance excellence

Progress & next steps

- ☐ The Charter of Governing Principles for Regulation was adopted by Regional Council on December 14, 2017
- ☐ Municipal processes to implement the Charter are being developed including a tool to calculate the cost of regulation to business
- ☐ Proposed amendments to regulation are being drafted to reduce the time it takes to process noise exemption requests for special event organizers and temporary sign applications for sign contractors
- ☐ Municipal processes are being improved to make "business-friendly" changes including customer service training for staff and better use of the municipality's website abilities to provide accessible information to businesses
- ☐ Measures to assess and monitor the performance of red tape reduction actions are being developed
- An update on the Project status will come to Council early spring
