


Together, we can **unite and ignite** the culture and heritage we share as a community as we observe the United Nations International Decade for People of African Descent from 2015-2024.

PROPERTY TAX SALES 2018

The Municipal

Government Act states that any property that has taxes outstanding for more than one year is eligible for a tax sale auction. It is mandatory for the municipality to attempt to notify the owner as well as all lien holders of the property regarding the pending sale by issuing a registered letter; however, this is not always possible and the property is then posted with a Tax Sale Notice. If the taxes remain unpaid, the property is advertised in the local paper twice prior to the tax sale.

Once the bidding commences, the owner or lienholders will not be able to withdraw the property and must partake in the bidding.

NEED HELP PAYING YOUR PROPERTY TAXES?

If you need help paying your property taxes, the municipality offers a few choices. You can apply for:

- A payment plan: rather than two large payments, you can pay in smaller monthly amounts.
- 2. **A rebate:** if your household income is less than \$33,000, the municipal government will pay a portion of your property taxes. The amount of rebate varies with income and residential tax.

- 3. A rebate and a deferral: after the rebate, has been applied to your tax account you can postpone payment of all or a portion of the balance. Interest is charged on the deferred tax amount. The rate of interest is set by Regional Council. For 2016 the interest rate is Prime -2% for customers in the program and Prime +2% for customers whose income now exceeds the limits and must start a repayment plan.
- 4. A deferral of local improvement charges: you can postpone payment of all or a portion of your local improvement charge.




Review your property assessment notice carefully

The provincial government sets the legislative framework for property assessment in Nova Scotia through the <u>Assessment Act</u>. The <u>Property Valuation Services Corporation</u> (PVSC), a not-for-profit corporation, determines your property's market value. The municipality uses that assessed value to calculate your <u>municipal tax bill</u>. Property taxes help to pay for services such as garbage pick-up, sewers, new roads and repairs, police and fire services, etc.

You have the right to appeal your property assessment. It is important to review your Notice of Assessment as soon as it is received as the appeal period is noted on the Notice of Assessment. Below is a figure outlining the appeal process.



If you agree with the outcome of the assessor's review, you do not need to do anything else. **PVSC will provide notification of the outcome to your municipality**. If you are not satisfied with the review by the PVSC assessor, you may continue your appeal with the Nova Scotia Assessment Appeal Tribunal – an independent, third party tribunal.
