<u>ORIGIN</u>

The Proposed 2018/19 Capital Budget.

LEGISLATIVE AUTHORITY

Under the HRM Charter, Section 79 Halifax Regional Council may expend money for municipal purposes.

The recommended contract award complies with all of the pre-requisites for awarding contracts as set out in section 34 of Administrative Order 2016-005-ADM, the *Procurement Administrative Order*.

Section 36 of the *Procurement Administrative Order*, provides that Halifax Regional Council may approve contract awards of any amount.

RECOMMENDATION

It is recommended that Halifax Regional Council award Tender No. 18-231, Asphalt Overlays Phase 1 – Various Locations, to the lowest bidder meeting specifications, Dexter Construction Company Limited for a Total Tender Price of \$1,790,602 (net HST included) with funding from Project Account No. CR000009 – Street Recapitalization, as outlined in the Financial Implications section of this report.

BACKGROUND

The Proposed 2018/19 Capital Budget includes funds for the Asphalt Overlay of Various Locations within the HRM.

Tender No. 18-231 was publicly advertised on the Province of Nova Scotia's Procurement website on March 14, 2018 and closed on March 29, 2018. Bids were received from following companies:

The scope of work for this tender generally consists of the milling of existing asphalt, installation of new asphalt, concrete curb and gutter repairs and associated reinstatement.

It is anticipated that work will commence within three weeks of the tender award and take 14 weeks to complete.

This is a **UNIT PRICE** contract and the cost will be dependent upon the actual quantities measured and approved by the HRM Project Manager.

There are no Local Improvement Charges associated with this work.

FINANCIAL IMPLICATIONS

Based on the lowest tendered price of \$1,717,010 plus net HST of \$73,592, for a net total of \$1,790,602, funding is available in the Proposed 2018/19 Capital Budget from Project Account No. CR000009 – Street Recapitalization. The budget availability has been confirmed by Finance.

*The projects included in this tender were estimated in the Proposed 2018/19 Project Budget at \$1,784,320.
