<u>ORIGIN</u>

December 7, 2015 – Grants Committee approval of proposed additions, deletions, renewals and records management changes for fiscal year 2015-16 as presented in the staff recommendation and information reports dated October 22, 2015.

December 8, 2015 – Notice of Motion for proposed amendments to Administrative Order 2014-001-ADM.

LEGISLATIVE AUTHORITY

RECOMMENDATION

It is recommended that the Grants Committee recommend that Regional Council repeal and replace Schedules 26, 27, 28, 29 and 30 of Administrative Order 2014-001-ADM Respecting Tax Relief to Non-Profit Organizations as set out in Attachments 2, 3, 4, 5, 6 and 7 of this report at a combined total cost of \$3,308,002 from Account M311-8006..

BACKGROUND

Discretionary tax relief provided by the Municipality is non-transferable and must be renewed annually. A recommendation and an information staff report dated October 22, 2015, were reviewed by the Grants Committee at their meeting of December 7, 2015 and accepted without amendments. The different levels of tax relief are described as Schedules as set out in sections 14, 15 and 16 of policy.

This report addresses only proposed amendments to the program's Schedules (removal, addition, renewals); applications not recommended for addition to the program or an increase in level of tax relief are listed in the Information Report to the Grants Committee dated October 22, 2015.

Note: Some awards are conditional: these restrictions are noted in the Recommendation Report to the Grants Committee dated October 22, 2015, but do not appear in the schedules affixed to Administrative Order 2014-001-ADM.

DISCUSSION

The recommendation in this report fall into two categories:

- 1. Proposed amendments to Administrative Order 2014-001-ADM Respecting Tax Relief to Non-Profit Organizations to coordinate policy and practice; and
- 2. Proposed changes included in the 'new' schedules included as Attachments, 2, 3, 4, 5, 6 and 7.

1. Proposed Amendments to Administrative Order 20014-001-ADM

The proposed amendments are intended to bring the Administrative Order in line with practice. The addition of a license agreement with HRM recognizes that in some circumstances a license is preferable to a lease agreement.

- Section 5A amended to require 3 of 5 years remaining in a lease or license agreement at the time that tax relief initially applied for. An applicant's eligibility is not compromised by the time to process application. In practice, the "time of application" shall be the stated application deadline for new applications or renewals.
- Clause 2(ea) added to include a license agreement with the Municipality and subsequent sections revised to include reference to same.

Note: Because a license is non-exclusive the inclusion of a license agreement is restricted to those issued by Halifax Regional Municipality. In practice there can be more than one license issued for a property or portion thereof, including private or for-profit interests.

- Section 2e(ii) added head-lease to include sub-leases within the definition of "lease".
- Section 7A late applications from renewals subject to pro-rated deduction. Late applications for the addition of 'new' properties or amended levels of tax relief remain ineligible.

 Section 5A(c) and 5B – inclusion of eligible non-profit or charity leasing from the non-profit property owner of the real property or eligible non-profit holder of the head-lease, at the same level of tax relief awarded the owner/head-lease. Clarification of a long-standing practice.

2. Proposed Awards Fiscal Year 2015-16

There are nine (9) changes proposed and included in the 'new' Schedules included as **Attachments 2**, **3,4, 5, 6 and 7**. The proposed changes are as follows:

- 1. the removal of ten (10) organizations from the tax relief program as detailed in Table 1 of this report;
- pro-rated tax relief for the Kinsmen Club of Dartmouth, Dartmouth Non-Profit Housing Society (357 Portland Street, Dartmouth) and Creighton/Gerrish Development Association at a combined cost of \$9,575;
- the removal of Metro Non-Profit Housing Society (2437 Maynard Street, Halifax), St. Leonard's Society of Nova Scotia (3170 Romans Avenue, Halifax) and Second Stage Housing Society (ANN#04013859 and ANN#09654720, Dartmouth) from Schedule 30 and the addition of these same properties to Schedule 28, effective April 1, 2015, at a combined <u>net</u> increased cost of \$7,394;
- 4. the addition of Feed Nova Scotia (215-217 Bedford Highway, Bedford) and Soccer Nova Scotia Training Centre Incorporated to Schedule 26, at a combined cost of \$0 in 2015-16 fiscal year;
- the addition of Fairview United Family Resource Centre and Metro Community Housing Association (30 Chartwell Lane, Halifax) to Schedule 28, effective April 1, 2015, at a combined cost of \$7,394;
- the addition of BFM Halifax Enterprises Society, Black Educators Association, Fisherman's Cove Development Association, Fung Loy Kok Institute of Taoism, Porter's Lake Community Services Association, and Royal Nova Scotia Tattoo Society (2250 Gottingen Street, Halifax) to Schedule 29, effective April 1, 2015, at a combined total cost of \$79,023;
- 7. the addition of 5534 Almon Street Incorporated, Adsum Association for Women and Children (209-15 Knightsbridge Drive, 205-110 Farnham Gate Road, 12-40 Veronica Drive, Halifax), Albro Court Housing Cooperative Limited (1 to 24 Cedar Court Dartmouth), City of Halifax Non-Profit Housing Society (5522 Buddy Daye Street, Halifax), Newfie Housing Cooperative Limited (31,55 and 61 Abby Road, 99,108 and 112 Bromley Road, 15 Cavendish Road, 115 Drumdonald Road, 112, 120 and 188 Ridgeway Road, and 44 Shepherd Road, Halifax), and Trillium Housing Cooperative Limited (1 to 26 Trillium Court, 66A Valkyrie Crescent and 49B Cranberry Crescent, Dartmouth) to Schedule 30, effective April 1, 2015, at a combined total cost of \$37,819;
- the renewal of tax relief for 626 properties as listed in Schedules 26 to 30, including an increase in tax relief for four (4) properties in Table 5, further detailed in the staff report dated October 22, 2015, effective April 1, 2015 unless stated otherwise, at an estimated combined cost of \$3,044,426;
- 9. all tax relief awards are conditional upon payment of any debt to the Municipality and/or pro-rated for default or any change in ownership or tenancy occurring within fiscal year 2015.
- Recommend Removal from Program in Fiscal Year 2015-16

Schedules 26, 27, 29 and 30 are amended with the removal of properties listed below in Table 1.

Pro-rated awards are recommended for the Kinsmen Club of Dartmouth, Dartmouth Non-Profit Housing Society (357 Portland Street, Dartmouth) and Creighton/Gerrish Development Association at a combined cost of \$9,575.

Recommend Increase in Level of Tax Relief

A modest increase is recommended for three (3) supportive housing providers, all of which are registered Canadian charities that operate supportive housing facilities in the urban core. If approved, an increase in tax relief would reduce the average tax per unit to below the average tax paid by homeowners (\$2,515)¹ and the average tax paid by lower income homeowners under the *Residential Tax Rebate Program* (\$1,051)² as shown below in Table 2.

Note: if approved, the <u>net</u> increase in cost of tax relief is \$7,394 and is included in the total cost of renewals in Table 5 (Schedule 28).

Recommend Tax Relief: Leases to be Renewed

Administrative Order 2014-001-ADM limits tax relief to the property owner or those with a long-term written lease billed directly by HRM. Several organizations previously accepted into the program are in long-term leases with HRM which have either not been formalized in writing or have expired and the holdover term does not conform to current policy. While they generally meet the intent of the program these contracts do not meet the technical requirements of current policy. As such, these organizations have been removed from the applicable Schedule but it is recommended that for fiscal year 2015-16 tax relief continue through Account M311-8006 as per the level of tax relief they would otherwise receive pending either (i) a new written lease, or (ii) the disposal of a surplus municipal property through Administrative Order 50.

Pro-Rated Late Renewals: To date, Council has not accepted revoking tax relief for late renewal applications. In the alternative, a pro-rated deduction of one day's eligibility for each day late avoids an abrupt "all-or-nothing" penalty while acknowledging that the vast majority of program participants abide by the program's policies and/or respond to reminder notices issued by HRM. The aim of pro-rating is not to save money; it is a default prevention technique to encourage program participants to self-manage. As of the date of this report a total of eight (8) organizations have been notified of a recommendation to pro-rate any tax relief approved for fiscal year 2015-16⁴.

FINANCIAL IMPLICATIONS

All figures in this report have been rounded to the nearest dollar and are estimates that exclude any assessment appeal or account corrections.

Revision: the figures below differ from those presented in the Recommendation Report to the Grants Committee dated October 22, 2015, due to non-renewal of a lease agreement with the Lake Echo Lions Club-

A balance of \$226,998 is insufficient budget capacity for 2016 fiscal year *if current levels of exemption were to be renewed*. This shortfall in capacity will be due to the addition of Soccer Nova and Feed Nova

Note to Financial Implications: The value of proposed renewal of leases removed from the program is included in this report to show the total combined cost of all awards proposed in 2015-16. Approval of tax relief for the leases is requested in a separate report to the Audit & Finance Standing Committee. The cost of these awards will be deducted from M311-8006 as stated.

ADMINISTRATIVE ORDER 2014-001-ADM TAX RELIEF TO NON-PROFIT ORGANIZATIONS ADMINISTRATIVE ORDER

BE IT ENACTED by the Council of the Halifax Regional Municipality, under the authority of the Halifax Regional Municipality Charter, 2008 S.N.S. c. 39, as amended, as follows:

Short Title

1. This Administrative Order may be cited as Administrative Order 2014-001-ADM, the *Tax Relief For Non-Profit Organizations Administrative Order.*

Interpretation

2. In this Administrative Order,

(a) "Council" means the Council of the Municipality;

(b) "dwelling unit" means a dwelling unit as defined by clause 3(z) of the *Halifax Regional Municipality Charter*, S.N.S., 2008, c. 39, as amended;

(c) "fiscal year" means the period of time from April 1st of a given calendar year up to and including March 31st of the next calendar year;

(d) "Government" means the Government of Canada, Government of the Province of Nova Scotia, a corporation that is an agent of Her Majesty in Right of Canada or the Province, a First Nation, the Municipality and a service commission;

(e) "lease" means a written contractual agreement signed by both;

(i) the owner of the real property and the occupant of the real property whereby the lessee has care and control over the real property by mutual agreement in accordance with the terms and conditions of the agreement; or

 (ii) the lessee of the real property and the occupant of the real property whereby the sub-lessee has care and control over the real property by mutual agreement in accordance with the terms and conditions of the agreement;

(ea) "license" means a written contractual agreement signed by the Municipality and another organization whereby the organization has the permission of the Municipality to use or occupy real property in which the Municipality has an estate, right, title or interest in,

(f) "Municipality" means the Halifax Regional Municipality;

(g) "non-profit organization" includes:

(i) a society incorporated pursuant to the *Societies Act*, R.S.N.S.1989 c.435, as amended,

(ii) a non-profit association incorporated pursuant to the *Co-operative Associations Act,* R.S.N.S.1989 c. 98, as amended,

(iii) a non-profit association to which the *Co-operative Associations Act* applies,

(iv) a not-for-profit corporation incorporated pursuant to the *Canada Not-for-profit Corporations Act,* S.C. 2009, c. 23, and

(v) a non-profit organization otherwise incorporated pursuant to an Act of the Nova Scotia Legislature;

(h) "service commission" means a service commission as defined by clause 3(bj) of the *Halifax Regional Municipality Charter*; and

(i) "tax relief" means a grant or contribution provided by the Municipality pursuant to sections 14 and 16 of this Administrative Order.

Application for Tax Relief

3. For an initial application for tax relief, an applicant must provide to the Municipality:

- (a) a copy of its Articles of Incorporation;
- (b) proof satisfactory to the Municipality respecting:
 - (i) the ownership of the property for which tax relief is sought such as a deed, or

(ii) the occupancy of the property for which tax relief is sought such as a signed lease agreement or license agreement;

- (c) a complete financial statement for the prior fiscal year of the applicant including:
 - (i) all revenues and expenses, assets and liabilities of the applicant, and
 - (ii) list of the Board of Directors of the applicant; and
- (d) a description of the program or service provided by the applicant.
- 4. For a subsequent application for tax relief, the applicant must provide to the Municipality:
- (a) the information required pursuant to clauses 3c and 3d of this Administrative Order; and

(b) any change of ownership or occupancy relating to the real property for which tax relief has previously been provided.

Eligibility of Non-Profit Organization for Tax Relief

4A. To be eligible for consideration by the Council for tax relief pursuant to this Administrative Order, a non-profit organization:

- (a) shall be one of the following:
 - (i) a charitable organization,
 - (ii) a community organization,
 - (iii) a cultural organization,
 - (iv) an educational organization,
 - (v) a fraternal organization,

- (vi) a recreational organization,
- (vii) a religious organization, or
- (viii) a sporting organization;
- (b) shall be:

(i) registered with the Registrar of Joint Stock Companies or with Corporations Canada, or

(ii) created by a statute that expressly names the non-profit organization; and

(c) shall own, license or lease real property as set out in sections 5 or 5A of this Administrative Order.

Eligibility of Registered Canadian Charitable Organization for Tax Relief

4B. To be eligible for consideration by the Council for tax relief pursuant to this Administrative Order, a registered Canadian charitable organization:

(a) shall be a charitable organization registered pursuant to the *Income Tax Act* (Canada) and the regulations made pursuant to that *Act*; and

(b) shall own, license or lease real property as set out in sections 5 or 5A of this Administrative Order.

Provision of Tax Relief for Owned Property

5. Council may provide tax relief to an eligible non-profit organization or an eligible registered Canadian charitable organization that owns real property that is located within the Municipality.

Provision of Tax Relief for Licensed or Leased Property

5A. Council may provide tax relief to an eligible non-profit organization or an eligible registered Canadian charitable organization that leases or has a license for real property that is located within the Municipality if:

(a) the real property is leased or licensed, for a minimum of five (5) consecutive years with a minimum of three (3) years remaining at the time tax relief is initially applied for, from

- (i) the Government,
- (ii) another non-profit organization or registered Canadian charitable organization,
- (iii) another person, or
- (iv) another entity;
- and

(b) the lease or license requires an eligible tenant non-profit organization or an eligible tenant registered Canadian charitable organization to pay the real property taxes on that portion of the real property that has been leased or licensed to the eligible organization.; and

(c) the real property is owned by a non-profit organization or registered Canadian charitable organization and it is leased to another non-profit organization or registered Canadian charitable organization, the applicant is the owner of the property and such owner provides to the Municipality:

(i) the lessee's registration number listed in either the Registry of Joint Stock Companies or the charities listings of the Canada Revenue Agency;

- (ii) a copy of the signed lease; and
- (iii) the total area the lessee occupies under the lease.

5B If clause 5A(c) applies, the amount of tax relief provided to the eligible lessee shall be the lesser of the amount of tax relief provided to the owner of the property or the total amount of the tax relief provided to the owner of the property divided by the area of the property occupied by the eligible lessee.

Pro Rata Tax Relief

6. (1) If tax relief has been provided pursuant to this Administrative Order, the amount of tax relief shall be pro-rated based on the proportional occupancy of the subject real property by an eligible non-profit organization or an eligible registered Canadian charitable organization and the duration of such occupancy during the current taxation year as follows:

(a) that portion of the real property leased, sub-leased or occupied by Government, another person or another entity must be excluded from eligibility for tax relief and the amount of tax relief must be pro-rated based on the proportional share of non-profit organization or registered Canadian charitable organization occupancy, expressed as a percentage for the entire real property;

(b) if any portion of the real property owned by an eligible non-profit organization or an eligible registered Canadian charitable organization for which tax relief has been provided is conveyed to a Government, another non-profit organization or another registered Canadian charitable organization, another person or another entity, the amount of tax relief shall be calculated by,

(i) dividing the number of days in the calendar year by the dollar amount of the tax relief; and

(ii) multiplying the result of sub-clause (b) (i) of this clause by the number of days the eligible non-profit or eligible registered Canadian charity organization owned the real property.

(c) if the lease or license is terminated for any reason or expires prior to the end of the current taxation year, the amount of tax relief shall be calculated by:

(i) dividing the number of days in the calendar year by the dollar amount of the tax relief; and

(ii) multiplying the result of sub-clause (c) (i) of this clause by the number of days the eligible non-profit or eligible registered Canadian charity organization leased or licensed the real property.

(2) For greater certainty, a vacant portion of the real property that:

(a) is the subject of tax relief that has been provided,

(b) is owned by an eligible non-profit organization or an eligible registered Canadian charitable organization,

(c) is vacant, and

(d) is not otherwise ineligible for tax relief or subject to a pro-rate reduction, is eligible for tax relief.

7. Where tax relief is provided pursuant to this Administrative Order and the property owner or lessee or licensee terminates the lease or license for any reason or the lease or license expires prior to the end of the fiscal year the amount of tax relief must be calculated by:

(a) dividing the number of days in the calendar year by the dollar amount of the tax relief; and

(b) multiplying the result of clause (a) of this section by the number of days the eligible non-profit or eligible registered Canadian charity organization is in possession of the property.

7A Where

(a) the real property is owned by a non-profit organization or registered Canadian charitable organization and it is leased to another non-profit organization or registered Canadian charitable organization; and

(b) tax relief is provided pursuant to this Administrative Order to the eligible lessee; and

(c) the owner of real property is no longer eligible for tax relief or the tax relief is pro-rate;

then the tax relief of the eligible lessee shall terminate.

7B If the application for renewal of tax relief has been filed with the Municipality after the advertised deadline for such applications and the applicant had previously been provided tax relief for the property or one of the properties that is the subject of the application for the prior taxation year, the amount of tax relief for the property or properties that were previously provided tax relief shall be reduced by the 1/365 for every calendar day such application is late.

Provision of Tax Relief

8. The provision of tax relief to an eligible non-profit organization or an eligible registered Canadian charity organization is at the sole discretion of the Council.

Tax relief for a subsequent taxation year is at the sole discretion of the Council.

10. Any tax relief provided by the Council pursuant to this Administrative Order must exclude that portion of the owned or leased or licensed real property that is used as a dwelling unit for an employee of the eligible non-profit organization or the eligible registered Canadian charitable organization.

11. Tax relief provided by the Council pursuant to this Administrative Order is valid only for the fiscal year in which it was applied for and cannot be awarded retroactively to a prior fiscal year.

12. Tax relief is not transferable including not being transferable to another person, organization, entity or other real property.

13. Tax-relief is not transferable including not being transferable to another person, organization, entity or other real property Repeal.

13A. Any tax relief provided under this Administrative Order shall be subject to the eligible nonprofit organization or an eligible registered Canadian charitable organization:

(a) complying with any obligation owed to the Municipality respecting any other grant program of the Municipality; and

(b) all taxes owed by such organization to the Municipality have been fully paid or all instalments or interim payments for taxes that are due to the Municipality have been paid as of the date of Council awarding tax relief.

Tax Relief - Conversion to Residential Rate

14. The amount of tax relief provided by the Council to an eligible non-profit organization or an eligible registered Canadian charitable organization named in a Schedule attached to this Administrative Order is equal to a conversion of its current tax rate to the residential tax rate.

- 15. In determining the amount of the residential tax rate pursuant to this Administrative Order:
 - (a) the following amounts of real property tax are eligible for tax relief:
 - (i) area rates or uniform charge except for a business improvement district area rate;
 - (ii) mandatory provincial contributions; and
 - (iii) the fire protection rate.
 - (b) the following amounts of real property tax are not eligible and are excluded from tax relief:
 - (i) an area rate levied for a business improvement district,
 - (ii) charges imposed or fixed pursuant to a by-law including a subdivision by-law,
 - (iii) fees, fines or interest owed to the Municipality for arrears on taxes, and
 - (iv) any other amount that is not specified pursuant to clause (a) of this section.

Tax Relief - Reduction of Residential Rate

16. For an eligible non-profit organization or an eligible registered Canadian charitable organization named in Schedules 26, 27, 28, or 30 there is a further reduction of the residential tax rate of those named in:

- (a) Schedule 26 one hundred percent (100%);
- (b) Schedule 27 seventy-five percent (75%);
- (c) Schedule 28 fifty percent (50%);
- (d) Schedule 30 twenty-five percent (25%); and
- (e) Schedule 29 zero percent (0%)

Referral by Council

17. The question of the tax relief for a particular property pursuant to this Administrative Order may be referred by the Council to a Standing Committee or to the Council in Committee for a recommendation to the Council on whether to provide tax relief.

<u>Schedules</u>

18. Schedules 26, 27, 28, 29 and 30 attached hereto form part of this Administrative Order.

 - (a) adding a colon after the word "both";
 - (b) numbering the remainder of the clause as sub-clause (i) of clause 2(e);
 - (c) adding the word "or" after the semi-colon in the newly numbered sub-clause (i); and
 - (d) adding sub-clause (ii) after sub-clause (i) as follows:

(ii) the lessee of the real property and the occupant of the real property whereby the sub-lessee has care and control over the real property by mutual agreement in accordance with the terms and conditions of the agreement;

2. Clauses 2(ea) is added after clause 2(e) and before clause 2(f) as follows:

(ea) "license" means a written contractual agreement signed by the Municipality and another organization whereby the organization has the permission of the Municipality to use or occupy real property in which the Municipality has an estate, right, title or interest in,

3. Sub-clause 3(b)(ii) is amended by adding the words "or license agreement" after the word "agreement" and before the semi-colon.

- 4. Clause 4A(c) is amended by adding the comma and word ", license" after the word "own" and before the word "or".
- 5. Clause 4B(b) is amended by adding the word and comma ", license" after the word "own" and before the word "or".
- 6. The header of section 5A is amended by adding the word "Licensed or" after the word "for" and before the word "Leased".
- 7. Section 5A is amended by:
- (a) adding the words "or has a license for" after the word "leases" and before the word "real";
- (b) adding the word "or licensed" after the word "leased" and before the comma in clause a;

(c) adding the words "at the time tax relief is initially applied for" after the word "remaining" and before the comma and word ", from" in clause a;

(d) adding the word "or license" after the word "lease" and before the word "requires" in the first line of clause b and adding the words "or licensed" after the word "leased" and before the words "to the" in the third line;

(e) striking out the period at the end of clause b and adding a semi-colon and the word "; and" at the end of the clause;

(f) adding clause c as follows:

(c) the real property is owned by a non-profit organization or registered Canadian charitable organization and it is leased to another non-profit organization or registered Canadian charitable organization, the applicant is the owner of the property and such owner provides to the Municipality:

- (i) the lessee's registration number listed in either the Registry of Joint Stock Companies or the charities listings of the Canada Revenue Agency;
- (ii) a copy of the signed lease; and
- (iii) the total area the lessee occupies under the lease.
- 8. Section 5B is added after section 5 and before section 6 as follows:

5B If clause 5A(c) applies, the amount of tax relief provided to the eligible lessee shall be the lesser of the amount of tax relief provided to the owner of the property or the total amount of the tax relief provided to the owner of the property divided by the area of the property occupied by the eligible lessee.

9. Clause 6(1)(c) is amended by:

(a) by adding the words "or license" after the word "lease" and before the words "is terminated" in the first line of the clause; and

(b) adding the words "or licensed" after the word "leased" and before the words "the real" in sub-clause (ii) of the clause.

10. Section 7 is amended by:

(a) adding the words "or licensee" after the word "lessee" and before the word "terminates";

(b) adding the words "or license" after the word "lease" and before the words "for any";

and

- (c) adding the words "or licensed" after the word "lease" and before the word "expires".
- 11. Sections 7A and 7B are added after section 7 and before section 8 as follows:
 - 7A Where
 - (a) the real property is owned by a non-profit organization or registered Canadian charitable organization and it is leased to another non-profit organization or registered Canadian charitable organization; and

(b) tax relief is provided pursuant to this Administrative Order to the eligible lessee; and

(c) the owner of real property is no longer eligible for tax relief or the tax relief is prorate;

then the tax relief of the eligible lessee shall terminate.

7B If the application for renewal of tax relief has been filed with the Municipality after the advertised deadline for such applications and the applicant had previously been provided tax relief for the property or one of the properties that is the subject of the application for the prior taxation year, the amount of tax relief for the property or properties that were previously provided tax relief shall be reduced by the 1/365 for every calendar day such application is late.

12. Section 10 is amended by adding the words "or licensed" after the word "leased" and before the word "real".

- 13. Section 13 is repealed.
- 14. Section 13A is added after the repealed section 13 and before section 14 as follows:

13A. Any tax relief provided under this Administrative Order shall be subject to the eligible non-profit organization or an eligible registered Canadian charitable organization:

(a) complying with any obligation owed to the Municipality respecting any other grant program of the Municipality; and

(b) all taxes owed by such organization to the Municipality have been fully paid or all instalments or interim payments for taxes that are due to the Municipality have been paid as of the date of Council awarding tax relief.

15. Repealing Schedules 26, 27, 28, 29 and 30.

16. Adding Schedules 26, 27, 28, 29 and 30 as attached to this amending Administrative Order as Attachments 3,4,5,6, and 7.
