SUBJECT: Proposed By-law R-108, An Amendment to By-law R-100 Respecting the

Repeal of By-laws and Ordinances

ORIGIN

Report originates as part of the By-law Review Project, which involves the review, updating and consolidation of By-laws and a 2014/15 Business Plan, Community and Recreations Services Deliverable, "Review and consolidate by-laws A-200 Automatic Machines and A-501 Licensing of Persons Monitoring Automatic Machines".

LEGISLATIVE AUTHORITY

Halifax Regional Municipality Charter ("HRM Charter") subclause188(2)(e)(i) - Without restricting the generality of subsection (1) but subject to Part VIII, the Council may, in any by-law;

- (e) provide for a system of licences, permits or approvals, including any or all of
 - (i) establishing fees for licences, permits or approvals, including fees for licences, permits and approvals that may be in the nature of a reasonable tax for the activity authorized or for the purpose of raising revenue, which fees may be set or altered by policy,

By-law R-100, the By-law and Ordinance Repeal By-law

RECOMMENDATIONS

It is recommended that Halifax Regional Council:

- 1. Adopt By-law R-108 as contained in Appendix A to repeal the following:
 - (a) By-law 15100 Trade and Licensing By-law (Bedford);

- (b) By-law A-501 Automatic Machines, Games Tables, Vending Machines and Mechanical Rides (Dartmouth);
- (c) By-law 15 Trade and Licensing By-law (County of Halifax);
- (d) By-law A-200 Automatic Machines (HRM); and
- 2. Amend Administrative Order 15 as contained in Appendix C.

BACKGROUND

This report is a result of a review of By-law A-200, Respecting Automatic Machines, as part of the ongoing By-law Review Project. The work to complete this report began under Community and Recreation and continues under Planning and Development following the restructuring and realignment of department responsibilities. This report is part of the overall comprehensive review and consolidation of the Municipality's by-laws.

As a result of this review, the following by-laws have been identified as no longer required and are recommended for repeal.

By-law No. 15100, Trade and Licensing By-law (Bedford)

By-law 15100 is a 35 year old by-law enacted by Bedford Town Council in October 1983. This by-law applies to the licensing of auctioneers, peddlers, hawkers, photographers, circuses, amusement facilities, skating rinks, dance halls and nightclubs, etc. Reports relative to the document's creation and reason for the specific licenses within the legislation are no longer available.

By-law A-501, Automatic Machines, Games Table, Vending Machines and Mechanical Rides (Dartmouth)

By-law A-501 is a 28 year old by-law enacted by the City of Dartmouth in February 1990. This by-law applies to the licensing of automatic machines, gaming tables, jukeboxes and vending machines. Reports relative to the document's creation and reason for the specific licenses within the legislation are no longer available.

By-law No. 15, Trade and Licensing By-law (County)

By-law No.15 is a 46 year old by-law enacted by the Halifax County Municipality in January 1972. This by-law applies to the licensing for the removal and collection of sewage. Reports relative to the document's creation and reason for the specific licenses within the legislation are no longer available.

By-law A-200, Respecting Automatic Machines (HRM)

In March of 2004, Halifax Regional Council passed By-law A-200 Respecting Automatic Machine. This by-law is the partial consolidation of most of the aforementioned by-laws of the City of Halifax, Dartmouth, Halifax County Municipality and Town of Bedford. This by-law applies to the licensing of Automatic Machines, including amusement, bulk, laundry and vending machines.

The staff report to Regional Council, dated October 24th, 2003, recommending the adoption of HRM By-Law A-200 Respecting Automatic Machines, describes the rationale for the licensing fee. The report states, "The license fee is levied in lieu of business occupancy tax for business whose machines are not covered by their business occupancy tax (i.e. coin-operated /dryers in an apartment building, pop vending machines in a mall.)"

DISCUSSION

By-law No. 15100, Trade and Licensing By-law (Bedford)

In March 2004 with the enactment of HRM By-law A-200, the majority of By-law 15100 was repealed. The remaining items in this legislation, peddler, trader and photographer are covered under HRM Vending By-law C-501. The other items, circus, bowling alley, skating rink, dance hall, night clubs and amusement rides are covered by overlap legislations with the Province of Nova Scotia. The provincial legislation includes the Gaming Control Act, Liquor Control Act, and the Theatres and Amusements Act. The licensing fees associated with the remaining items of this by-law were never adopted in Administrative Order #15, Respecting License, Permit and Processing Fees.

By-law A-501, Automatic Machines, Games Table, Vending Machines and Mechanical Rides (Dartmouth)

In March 2004 with the enactment of HRM By-law A-200, the majority of By-law A-501 was repealed. The items remaining in this legislation, automatic machines, game tables, jukebox and vending machine are covered by overlapping legislation with HRM's By-law A-200. The licensing fees associated with the remaining items of this legislation were never adopted in Administrative Order #15, Respecting License, Permit and Processing Fees.

By-law No. 15, Trade and Licensing By-law (County)

The only item remaining in this legislation is the licensing for the removal and collection of sewage is covered by the Province of NS Environment Act, On-Site Sewage Disposal Systems Regulations. The licensing fee associated with the remaining item of this legislation was never adopted in Administrative Order #15, Respecting License, Permit and Processing Fees.

By-law A-200, Respecting Automatic Machines (HRM)

Halifax Regional Council passed By-law A-200 in March 2004. This by-law was the partial consolidation of previous by-laws of the City of Halifax, Dartmouth, Halifax County Municipality and Town of Bedford. In September 2006, with the approval of By-law C-500 Commerce and Vending on Municipal Lands, the licensing of newspaper boxes was removed from By-law A-200. Staff's current perspective is that By-law A-200 is no longer required due to the following:

- Automatic Machines are mostly housed on private properties within a current business establishment or residential complex;
- Automatic Machines at curbside are mostly non-existent or dispensing free materials;
- The demand and popularity of Automatic Machines has greatly declined; and
- HRM does not inspect businesses for automatic machines.

Currently, Halifax has no responsive or proactive enforcement of By-law A-200. Owner compliance with A-200 is strictly voluntary. The services Planning and Development staff provide, relative to this by-law, are exclusively administrative. Annual invoices are issued and once payment is received licenses are issued. The licensing revenue from the past two fiscal years have averaged \$154,000 per year; residential units housing licensed laundry machines accounted for approximately 60% of the revenue. The remaining 40% of the revenue is generated from the licensing of Amusement Machines, Bulk Food Machines and Snack & Beverage Machines, the majority of which are housed in commercial / business environments or residential units. The business occupancy tax has now been phased out (April 1, 2013), so there is no need for this fee from a commercial tax equity standpoint.

To provide an effective and fair process, HRM would need to develop and implement a licensing enforcement strategy. This would neither be cost effective nor practical; it would require entry onto private property for the purpose of identifying the type and number of Automatic Machines with compliance follow

up and penalty or remedy schemes. Full implementation would involve substantial resources and management.

The elimination of the licencing of Automated Machines, would not impact the 2018-19 fiscal year budget as no revenue for Automated Machines has been included in the budget.

FINANCIAL IMPLICATIONS

The repeal of By-law A-200, Respecting Automatic Machines, will reduce HRM revenues by approximately \$154,000 per year, based on the actual revenues received in recent years.

In anticipation of the repeal of By-law A-200 this year, the 2018-19 operating budget for Planning and Development – cost centre S330 - 5204 (Administration Fees) – was adjusted to reflect the proposed change.

RISK CONSIDERATION

There are no significant risks associated with the recommendation in this report. The risks considered rate low.

COMMUNITY ENGAGEMENT

Community engagement is not applicable with this report.

ENVIRONMENTAL IMPLICATIONS

There are no environmental implications associated with the recommendation in this report.

ALTERNATIVES

1. Regional Council could choose not to repeal any or all of the following by-laws:

By-law 15100 Trade and Licensing By-law (Bedford)

By-law A-501 Automatic Machines, Games Tables, Vending Machines and Mechanical Rides (Dartmouth)

By-law 15 Trade and Licensing By-law (County)

By-law A-200 Automatic Machines (HRM)

A decision to not repeal these by-laws is not recommended by staff, as the by-laws have either been superseded by other legislation, are obsolete, or no longer reflect the corporate priorities.

2. Regional Council could chose to direct staff to establish a proactive enforcement strategy for licensing of Automatic Machines. This is not recommended by staff.

HALIFAX REGIONAL MUNICIPALITY BY-LAW NUMBER R-100 BY-LAW RESPECTING THE REPEAL OF BY-LAWS AND ORDINANCES

BE IT ENACTED by the Council of the Halifax Regional Municipality, as follows:

Short Title

1. This By-law shall be known as By-law No. R-100 and may be cited as the "By-Law and Ordinance Repeal By-law".

Repeal of By-Laws and Ordinances

- 2. The following by-laws and ordinances are repealed:
- (a) Ordinance 121, the City of Halifax Retail Shop Closing Ordinance, effective January 1, 1997.

 - (c) Section 4 of By-Law 23290 of the former Town of Bedford is repealed.

 - (e) The City of Dartmouth By-laws listed in Schedule "B" hereto annexed and any amendments thereto;

 - (g) The Halifax County Municipality By-laws listed in Schedule "D" hereto annexed and any amendments thereto.
 - (h) The Halifax Regional Municipality By-laws listed in Schedule "E" hereto annexed and any amendments thereto.
 - (i) Subsection 1 of Section 23 of the City of Dartmouth Mobile Homes and

Mobile Home Parks By-law (M-200) is amended by

- (a) adding the word "and" after the semicolon in clause (a);
- (b) deleting and replacing the semicolon in clause (b) of subsection (1) with a period;
- (c) deleting clause (c);
- (j) Subsection (2) of Section 23 of the City of Dartmouth Mobile Homes and Mobile Homes Parks By-law is repealed.
- (k) Section 24 of the City of Dartmouth Mobile Homes and Mobile Homes Parks By-law (M-200) is amended by:
 - (a) deleting the colon after the word "if" and adding the words "the Mobile Home Park complies with the provisions of this By-law", and;
 - (b) deleting clauses (a) and (b).
