<u>ORIGIN</u>

Motion from the September 26, 2018 meeting of the Heritage Advisory Committee, Item 9.3.

LEGISLATIVE AUTHORITY

Heritage Property Act, R.S.N.S., 1989, c. 199, section 22:

"Financial Assistance 22(1) The Minister, subject to the approval of the Governor in Council, may provide financial assistance in respect of provincial heritage property and the council may provide financial assistance in respect of municipal heritage property or property located in a heritage conservation district to any person to assist in the restoration or renovation of such property upon such terms and conditions as the Minister or the council, as the case may be, deems fit." Administrative Order Number 2014-002-ADM, Respecting the Heritage Incentives Program

HRM By-law No. H-200 - Heritage Property By-law

- 4. The [Heritage Advisory] Committee shall, within the time limits prescribed by Council or the [Heritage Property] Act, advise the Region respecting:
 - (n) financial incentives to heritage properties;

RECOMMENDATION

Recommends that Regional Council:

 Approve the provision of in-kind financial assistance of a value up to but not exceeding \$150,000, with a net municipal project cost up to but not exceeding \$75,000, to the Parish of St. Paul's for the continued restoration of a portion of the perimeter ironstone wall and cast iron fencing surrounding St. Paul's Church in accordance with the Heritage Agreement dated November 24, 2017 and the proposed amendments thereto, with funding as outlined in the Financial implications section of the staff report dated August 23, 2018, conditional on:

- a) a.The execution of an amendment to the Heritage Agreement dated November 24, 2017, and its registration at the Land Registry Office; and
- b) b.The execution of a Contribution Agreement with the Government of Canada;
- 2. Authorize the CAO to negotiate, and the Mayor and Clerk to execute, an amending agreement to the November 24, 2017 Heritage Agreement between HRM and the Parish of St. Paul's, to include:
 - a. The provision of in-kind financial assistance of a value up to but not exceeding \$150,000, with a net municipal project cost up to but not exceeding \$75,000, for the continued restoration of a portion of the perimeter ironstone wall and cast iron fencing surrounding St. Paul's Church, subject to the execution of a Contribution Agreement between HRM and the Government of Canada;
 - b) b.The identification of the new area to be restored in accordance with Map 1; and
 - c) c.The completion date of the new work, being no later than March 31, 2019.The Heritage Advisory Committee recommends that Regional Council approve the recommended grants to the properties listed in Attachment A, and approve as "standby' the recommended properties listed in Attachment B, conditional upon the applicants' compliance with Section 29 through 35 of Administrative Order Number 2014-002-ADM.
