THE Grantors and the Grantees hereby agree with each other and for their heirs and assigns to:

A)Share equally the cost of construction of the said well and laying of pipes;

B) Share equally the cost of maintenance and repair of the said well and pipes;

TOGETHER WITH an Agreement made between John D. Murray and Katherine Murray (hereinafter called the Grantors) - and - John Robert McMaster and Velma Ruth McMaster (hereinafter called the Grantees), said agreement is filed and recorded at the Registry of Deeds Office in Halifax County in Book 5440, Page 726 and is being more particularly described as follows:

THE Grantors doth affirm the right of the Grantees to use the well located on their property;

THE Grantees may do what is necessary for keeping and maintaining this well, and the pipes running the water to their home, in good condition and repair, provided that the same is done at the sole expense of the Grantees and the Grantors property is returned to the same state it had been prior to any maintenance or repair of the well or pipes.
