# Vehicle for Hire Industry Review Motion

Create a Request for Proposal (RFP) toward an in-depth industry review and jurisdictional scan including recommendations not limited to the following:

- Incorporating new industry technologies, e.g., in taxi video / audio recording systems,
- GPS real-time tracking systems, smartphone applications; etc.
- License restrictions;
- Sensitivity and Safety Training;
- Passenger/Driver safety measures, e.g., in car shields, emergency alarm buttons and
- passenger trip logs;
- Standards of professional, moral and ethical conduct of license holders; and
- Conditions that would result in an automatic suspension or revocation of a license



#### **Accessible Motion**

Request a staff report to the Transportation Standing Committee that will, after consultation with the Taxi & Limousine Liaison Group, taxi operators, dispatch companies, accessibility groups, and the Accessibility Advisory Committee to present options for the development of a service delivery contract or other arrangements with taxi operators and dispatch companies that will support a sustainable framework to ensure the 24 hour provision of an accessible taxi service.



### **Gender Diversity Motion**

That the Transportation Standing Committee request a staff report to assess options for improving gender diversity of taxi drivers in HRM, including the option of creating a new category of Taxi Owners Licences to be issued to females only with consideration to the following:

- That the proposed new category would offer owners licenses to females without requiring them to be placed on a wait list; and
- The completion of a jurisdictional scan and consultation with the Taxi and Limousine Liaison Group

## **Taxi Survey Overview**

- Poor service especially during weather events, weekend nights, large events ie. sports, New Year's Eve
- Accepting cash only
- Not driving fares outside of the downtown core
- Rude drivers
- Poor quality of vehicles
- Too expensive
- Long waits for taxis
- Not feeling safe
- Wanting Uber

Staff recommends:

- Global Positioning System (GPS)
- Mandatory training knowledge and cultural sensitivity, winter driving course

## Supply vs. Demand

Staff recommends:

• Increasing taxi owner license limitation from 1,000 to 1,600



#### **Accessible Service**

- Accessible licenses currently
- On-demand accessible 24-hour service
- Operating costs
- Programs of support historically
- Option of procuring accessible taxi services to supplement Halifax Transit Access-A-Bus

Staff recommends:

Amendment to the HRM Charter



#### **Preparation for Transportation Network Companies (Uber or Lyft)**

88% want Uber or Lyft according to the citizen survey with 73% citing safety as the main reason

Staff recommends:

A supplementary report to explore regulation



## **Licensing Brokers**

Staff recommends:

- Licensing brokers
- Increasing license fees



### **Gender Diversity**

- 25 female taxi license owners
- 13 female taxi drivers on waitlist
- No municipality has a female only category
- 66% from citizen survey would feel safer with an all-female taxi service

Staff recommends:

Increase limitations from 1,000 – 1,600



# Housekeeping Items for By-law and AO 39

- Criminal offense or major driving offense in the last 10 years
- Child Abuse Registry
- Criminal Record Check/Vulnerable Sector Check 30 days four months
- All vehicles accept credit card / debit
- Vehicle age no older than 7 years
- No talking with cell phones / headsets while operating vehicle for hire
- Motor Vehicle Inspection valid 30 days from expiry at minimum
- Require a staff report for taxi meter increase only
- Upgrade limousine standards



# Housekeeping Items for By-law and AO 39 cont'd

- Remove hotel standards
- Add cannabis and vaping to non-smoking section
- Halifax International Airport Authority shall set the rates from the airport
- Medical letter on file before service animal refusal
- Remove crossed out images in AO
- No limitations on accessible licenses individual or corporation



### **Taxi Survey - Results**

- 70% access to a car and 65% expense
- 71% not enough taxis, especially after 6 p.m.
- 90% use a dispatcher for service
- 88% would use Uber of Lyft
- 88% downtown Halifax
- 68% not pleased with the level of service in a taxi
- 66% would like an all-female taxi service



#### Taxi Survey – Results con't

Feel safer:

- 54% GPS systems
- 54% in-car cameras
- 73% Uber or Lyft
