
Active Transportation Facilities [PDF] in which the Transportation Standing

- Continue Municipal funding support for volunteer community associations who plan, build, maintain and promote active transportation facilities in the municipality;
- Develop an Administrative Order for Regional Council's consideration that updates roles and responsibilities and establishes a Municipal grant/contribution program to support the work of such associations; and
- Consult with community associations, the provincial government, the Halifax Regional Trails Association, HRM officials and other stakeholders in the development of this proposed Administrative Order on key issues as outlined in the discussion section of the August 10, 2018 staff report.



# **Background: AT Facilities Facts**



Making Connections 2014-2019 Active Transportation Priorities Plan

Map 3- Vision for a Regional Greenway and Bicycle Network

- Total envisioned: 320KM of MUPs
- 63% of MUPs are on land owned by the Province (former railways and parks)
- Total built by end of 2017 fiscal: 182 KM
- Total investment by end of 2017 fiscal: \$11.6 MIL



#### Background: Roles and Responsibilities (1) Halifax Regional Trails Association (HRTA)

- **Represent communities' interests:** unified framework for its members to meet responsibilities related to HRM funding programs
- **Funding screening:** sub-committees conduct peer review and evaluation of funding proposals and make recommendations to HRM
- Advocacy and Communications: represented in the HRM's Active Transportation Advisory Committee, and the Provincial Government's Inter-Governmental Committee on Trails through its membership in the Nova Scotia Trails Federation.
- **Collaboration**. HRTA is a forum for its members to report achievements, challenges, identify potential opportunities and share best practices.



### Background: Roles and Responsibilities (2) HRTA Trails Associations

#### "Operators"

- bound to legal agreements with the land owner; responsibilities: planning (routing options selection, community engagement, resource development), construction, maintenance/ operations, and recapitalization; fundraising, and insurance
- built 119km of trails since 1999, mostly on provincial land;
- reported \$12MIL funding from other sources since 1999

### Background: Roles and Responsibilities (2) HRTA Trails Associations

#### "Supporters"

- have mostly a planning and advocacy role; some have trail warden patrols, maintain trailheads/signage and do some maintenance as directed by licence agreement with HRM; lack of clear roles and responsibilities has been a source of frustration for these groups
- initiated project development for 23KM built by HRM, mostly on HRM land

#### Background: Roles and Responsibilities (3) Halifax Regional Municipality

- Provision of Funding: Capital/ Re-Capitalization and Maintenance Funding Programs;
- Establish Regional Active Transportation Plans: AT Priorities Plan and IMP determines project eligibility
- Planning and coordinator staff support community association "operators" -led projects (co- planning and funding coordination)
- Full project management for community association "supporters" initiated projects: TPW staff lead and deliver planning, conducting preliminary and detailed design and overseeing construction; groups are engaged during the planning stages
- Maintenance and operation of AT facilities: Operations staff maintain most of the multi-use pathways where trail groups have a "supporters" role



#### Background: Roles and Responsibilities (4) Nova Scotia Provincial Government

- Letter of Authority Process Administration: transfers responsibility for planning, construction, maintenance and operations to volunteer community associations; determine future uses and administration of the facility if a community group were to disband or relinquish its LOA
- Guarantor of insurance deductible for community-operated facilities:\$1,000,000 deductible requested for coverage by the insurance provider for all community associations who are members of the Nova Scotia Trails Federation (NSTF)- all HRTA members are included
- Funding support for AT facilities: Trail Maintenance: \$1,000 base plus \$100/KM for those on an LOA and "Off-Highway Vehicle" infrastructure fund for "shared-use" trails. Capital funding: Recreational Trail Expansion Program 33% up to \$150K; Trails Engineering Assistance Grant Program for structures; and Connect2.
- **Enforcement** with provincial wardens and conservation officers



#### Administrative Order Development Objectives (1)

- Update the administrative model and authority for HRM funding for community association projects
  - Formalize this legacy grant funding program and align with current plans and priorities
  - Direct staff on the required administrative steps to prioritize funding for AT Facilities identified in the current policy
  - Develop a contribution grant funding program model which allows staff to make decisions by evaluating applicant community groups and their proposals based on set criteria;
  - Consider whether non-HRTA member groups could be eligible to receive the Grants
- Consider four streams of funding to support capital, recapitalization, maintenance, promotion and education



## Administrative Order Development Objectives(2)

- Provide clarity on the roles and responsibilities of community associations who do not have agreements to build, maintain and operate facilities
- Manage risks and opportunities related to community associations' sustainability
- Confirm the inter-jurisdictional roles and responsibilities between HRM and the Province



# Administrative Order Development Objectives(3)

- Clarify Maintenance and Operations costs and responsibilities for HRM
- Determine a clear direction on HRM funding for facilities permitting Off-Highway Vehicles (OHVs)
- Respond to the request for an HRM funding program to support the construction and ongoing maintenance of recreational trails.
- Other issues as determined during stakeholder engagement.



## Administrative Order Development Scope (1)

- Establish a strong sponsorship team to support the project and engage major stakeholders in discussions
- Establish a working group to represent their respective area(s) on the project and support goals and objectives of the project related to their business unit and help support AO implementation
- Identify, evaluate and engage the stakeholders group impacted and/or needed to meet the objectives and to support transition and AO Implementation



# Administrative Order Development Scope(2)

- **Develop research and analysis** to support the development of the AO such as: key issues previously identified, jurisdictional scan, grants best practices
- **Develop "requirements summary"** to be incorporated in the report and AO
- Develop AO in partnership with Legal and include an operating model, processes and policies, new governance, roles and responsibilities
- **Develop Recommendation Report** to support the new AO; respond and make changes as needed based on feedback from ATAC and TSC in advance to being presented to the Regional Council



#### Stakeholders engagement registry

- Internal Stakeholders: Legal, Insurance and Risk Management and Finance (Community Grants) staff; Parks and Recreation;
- HRTA and member Trail Associations
- External stakeholders such as: the Province of Nova Scotia-Interdepartmental Committee on Trails (ICT) members, Nova Scotia Trails Federation, ATVANS and other OHV Clubs, ATAC, Accessibility Advisory Committee
- Other jurisdictions: scan and conversations
- Other AT groups of interest such as: Halifax Cycling Coalition, Walk'n Roll, Ecology Action Centre, Bicycle Nova Scotia



## Administrative Order Development Next Steps

- April 2019: Finalize engagement plan and deliverables
- Apr- Sept 2019: Stakeholder engagement sessions
- Apr- Aug 2019: Develop research to support the development of the AO
- June- Aug 2019: Develop requirements summary to inform the AO
- Sept- Oct 2019: Develop AO in partnership with Legal
- Oct- Nov 2019: Develop Recommendation Report
- Nov 2019- Dec 2020: Present AO and Recommendation Report to ATAC
- Jan 2020: Present AO and Recommendation Report to TSC
- Feb 2020: Present AO and Recommendation Report to the Regional Council
- Feb- March 2020: Transition as per new AO
- Apr 2020 and ongoing: Implementation of the new AO
