NS COASTAL PROTECTION PLAN

As reported back in August 2018, Issue #249, the Province has finished its Coastal Protection Plan consultations (from June 26th – August 17th, 2018) and released its summary report on that process: https://novascotia.ca/coast/CoastalProtectionLegislationConsultationReport.pdf Now we must await subsequent legislation and regulations that should provide clear rules on what can and cannot be done in areas next to the coast. The NS Dept. of Environment will have to work closely with municipalities and others to develop these regulations that will define how this legislation will work. This will impact any new proposed construction activity that may be near the shorelines that are likely to be threatened by coastal erosion, rising sea levels and storm surges.

LITTER CLEAN UP CAMPAIGNS



This spring, the NS Adopt a Highway will be kicking off its 2019 cleanup season with the Great Nova Scotia Pick-Me-Up: the province's largest litter reduction initiative. Registration is now open at www.nspickmeup.ca or by calling 902-843-3553. They will provide groups with everything needed to run a successful

litter clean-up event including supplies, information on how to coordinate your event and a data card to track results and be sure to post 'before & after' photos of your pick-me-up locations and post to social media using the hashtag #GladToCleanUp. CITY NATURE CHALLENGE HFX

The City Nature Challenge (CNC) is a global event that celebrates citizen scientists, biodiversity and our environment while providing valuable information to scientists about our natural world. Cities from across the world compete over four days (April 26th-29th) to see who can make the most observations of Nature, find the most species, and engage the most people taking pictures of wild animals, plants, and all other life. Participants in the CNC are encouraged to download the online platform iNaturalist (https://inaturalist.ca) to record observations. Use your mobile device or a camera and desktop computer, individuals simply snap a picture of a tree or frog or lichen and upload the photo to the iNaturalist site. The Halifax event will take place throughout the entire municipality. The CNC-HFX committee will be hosting several iNaturalist training workshops in advance of the event including April 6th (10:30am - 2:30pm) at the Fairbanks Centre, Shubie Park, in Dartmouth.
