SUBJECT: Appeal Report – Application for Taxi Driver License Denied, Mr. Bryan Newby

# **ORIGIN**

On June 5, 2019, Mr. Bryan Newby filed a Notice of Appeal (attached as Appendix B) regarding the refusal of his application for a vehicle for hire driver license.

# **LEGISLATIVE AUTHORITY**

- By-law A-100, Appeals Committee By-law; and
- By-law T-1000, Respecting the Regulation of Taxis, Accessible Taxis and Limousines.

#### **RECOMMENDATION**

The question before the Appeals Standing Committee is whether to allow or deny the appeal before them.

#### **BACKGROUND**

On April 30, 2019, Mr. Newby applied to the Licensing Authority for a vehicle for hire driver licence for the first time.

Upon review of the application package, the Licensing Authority determined that the Criminal Record Check provided was deemed to be unsatisfactory due to the following criminal conviction:

#### October 11, 2017

• SEC 253 (1) (B) Driving with more than 80mgs of alcohol in blood

His driver's abstract also showed that he lost his provincial driver's license from October 11, 2017 until October 17, 2018.

On May 23, 2019, the Licensing Authority issued a registered letter (attached as Appendix C) to Mr. Newby denying his application for a new vehicle for hire driver license in accordance with Section 44.2 (c) of By-law T-1000.

#### DISCUSSION

In accordance with Section 44.2 (c) of By-law T-1000, Respecting the Regulation of Taxis, Accessible Taxis and Limousines,

- **44.2** The Licensing Authority may refuse to grant a driver's license or may suspend or cancel a driver's license if
  - (c) the applicant or license holder has a driving record, criminal or provincial offence record or outstanding criminal charges that in the opinion of the Licensing Authority makes him or her unfit to operate a taxi, accessible taxi, or limousine, as the case may be;

In reaching the decision, the Licensing Authority considered the following:

The criminal conviction was within the last two years. Mr. Newby lost his provincial driver's license because of the conviction. The Licensing Authority has determined that it is in the public interest to deny his application for an HRM taxi driver license in accordance with Section 44.2 (c) of By-law T-1000 Respecting the Regulation of Taxis, Accessible Taxis and Limousines.

# Halifax Regional Municipality By-law T-1000

# Respecting the Regulation of Taxis, Accessible Taxis and Limousines

- **44.2** The Licensing Authority may refuse to grant a driver's license or may suspend or cancel a driver's license if
  - (a) the applicant or license holder has been convicted of an offence against vulnerable persons, a sexual offence, an illegal sale or possession of drugs, a violent offence or breach of trust;
  - (b) the applicant or license holder has failed to immediately notify the Licensing Authority that they have become the subject to a court order, undertaking, charge or conviction;
  - (c) the applicant or license holder has a driving record, criminal or provincial offence record or outstanding criminal charges that in the opinion of the Licensing Authority makes him or her unfit to operate a taxi, accessible taxi, or limousine, as the case may be; or

Mr. Newby,

This letter is in reference to your recent application dated April 30, 2019, to obtain a HRM vehicle for hire driver license.

Based on the Criminal Records Check that you provided as part of the taxi application, your application is rejected due to charges and convictions noted therein.

From By-law T-1000 Respecting the Regulation of Taxis, Accessible Taxis And Limousines:

- **44.2** The Licensing Authority may refuse to grant a driver's license or may suspend or cancel a driver's license if
  - (c) the applicant or license holder has a driving record, criminal or provincial offence record or outstanding criminal charges that in the opinion of the Licensing Authority makes him or her unfit to operate a taxi, accessible taxi, or limousine, as the case may be;

In accordance with Section 48 of By-law T-1000, Respecting the Regulation of Taxis, Accessible Taxis and Limousines, you have the right to appeal this cancellation within <u>15 days</u> from the date of the revocation.



**48.2** A person whose application is refused or a person whose owner's license or driver's license is suspended, revoked or cancelled by the Licensing Authority may appeal to the Appeals Standing Committee within 15 days after the <u>refusal</u>, suspension or cancellation <u>by submitting their appeal in writing to the Municipal Clerk's Office C/O Municipal Clerk, P.O. Box 1749, Halifax, NS, B3J 3A5</u>. Once filed, an appeals committee hearing will be scheduled.


