






# What is a Heritage Conservation District?

Urban or rural area with historic or architectural value established under the *Heritage Property Act*.





# What is a Heritage Conservation District?

**Municipal Heritage Properties** 


**Contributing Heritage Resources** 

#### **Legislative Authority**

Heritage Property Act, including section "19A (1) A municipality may establish a heritage conservation district by concurrently adopting a heritage conservation district plan and a heritage conservation district bylaw for a part of the municipality and there may be different conservation plans and conservation by-laws for different parts of the municipality."

#### Why is the Old South Suburb Significant?

#### St. Mary's Cathedral Basilica

The Cathedral Basilica is located on land purchased by the Irish Catholics of Halifax in 1784. Built between 1820 and 1829, it replaced a smaller church - St. Peter's - that was first erected on the site. St. Mary's has been the home of many Irish bishops, and many Halifax Irish who contributed to the growth and commerce of the city were its parishioners.

#### Former St. Peter's Cemetery

Located beside the Basilica at the corner of Spring Garden Road and Grafton Street, the old St. Peter's cemetery was used from the 1780s to the early 1840s when Holy Cross Cemetery was opened. It holds the remains of over 2000 Catholic parishioners, mainly Irish, along with Mi'kmaq and a scattering of Scots, German and English. The graveyard became a paved parking lot in the 1950s.

#### **Holy Cross Cemetery**


Holy Cross Cemetery was opened and the first burials made in 1843. Of the 25,000 persons buried there most are Irish immigrants and their descendants. Many headstones identify the county of Ireland as the decreased country of origin.

#### Our Lady of Sorrows Chapel

Located within the Holy Cross Cemetery, Our Lady of Sorrows Chapel is affectionately known as "The Church Built in a Day". Nearly 2000 volunteers gathered on August 31, 1843 to build the wooden chapel on its ironstone foundation.

#### Celtic Cross: Irish Settlers Memorial.

Erected March 17, 2000 by the Charitable Irish Society of Halifax.





#### **Heritage Value**

- Historic associations:
  - early settlement of Nova Scotia;
  - early social and economic life of the waterfront city; and
  - vibrant railway industry of the 1920s and 30s.
- Area of traditional architecture.



#### **Heritage Value**

Late Georgian Period (1800-1830)


















#### **Character Defining Elements**

- Two-and-a-half-storey height;
- Building widths are between 6 and 16 metres and depths are between 10 and 35 metres;
- Side yards and alleys;
- Roofs: pitched, truncated-pitched or Mansard roofs, with a few flat roofs;

Section 11

(2.2) The minimum setback from the front property line shall satify one of the following requirements:

(b) one metre greater than the greatest setback from the front lot line of an Old South Suburb Heritage Building located on the same street and on the same or abutting lot, where no structure is proposed to exceed 4.5 metres in height, within three metres of the side wall of an Old South Suburb heritage building for six metres from the front property line.
