ORIGIN

June 18, 2019 Halifax Regional Council motion:

MOVED by Councillor Walker, seconded by Councillor Blackburn "THAT Halifax Regional Council:

- 1. Approve 64 Events Grants for a total of \$211,750 as identified in Table 1 of the staff report dated May 27, 2019 from the approved Operating Budget C760 Community/Civic Events; ..."

LEGISLATIVE AUTHORITY

- 79A (1) Subject to subsections (2) to (4), the Municipality may only spend money for municipal purposes if (a) the expenditure is included in the Municipality's operating budget or capital budget or is otherwise authorized by the Municipality;
- Administrative Order Number 2014-021-GOV: Respecting Regional Special Events Grant.

RECOMMENDATION

It is recommended that the Grants Committee recommend that Halifax Regional Council approve a one time increase in funding in the amount of \$500 to the Sackville Business Association under the Community Celebrations Grant program for the Annual Sackville Christmas Tree Lighting event from the 2019/20 Operating Budget – C760 Community/Civic Events.

BACKGROUND

On June 18, 2019 Regional Council approved funding for the Annual Sackville Christmas Tree Lighting in the amount of \$500 as outlined in Attachment 1.

The Sackville Business Association (SBA) is a non-profit organization which represents organizations and businesses within the boundaries of the Sackville Business Improvement District ("BID"). The BID organizes this annual event which is free for members of the public to attend.

DISCUSSION

The rationale for recommending an additional \$500 in funding under the *Regional Special Events Grants Program* for the Annual Sackville Christmas Tree Lighting is to correct an error in the initial staff report. The recommended amount should have been \$1,000 which is consistent with prior years' funding and other similar established events, but was listed incorrectly in the amount of \$500. This traditional event consists of free live music, refreshments, a visit from Santa Clause and the lighting of the Christmas trees.

FINANCIAL IMPLICATIONS

All Community Celebrations, Significant Anniversaries and Established Community Festivals recommendations can be accommodated in the approved 2019/20 operating budget for Community/Civic Events account C760-6933.

RISK CONSIDERATION

There are no significant risks associated with the recommendation in the Report. The risks considered rate low. To determine this, consideration was given to financial and reputational risk.

COMMUNITY ENGAGEMENT

Information regarding program eligibility, application timelines, and applicant timelines are posted on the HRM website. The Grants Committee includes members of the public.
