


# What we are about

- Nova Scotia Association of Turtle Patrollers is a not-for-profit society that is aimed at assisting Nova Scotia fresh water turtles.
- Snapping turtles are our primary interest, but we will assist any species we are able to.
- We fully support the federal Management Plan for snapping turtles but feel that there is a specific piece missing regarding nests and young.

# Historic interactions with HRM

### Red Bridge Pond dry well replacement

- Guardians notified us of the work
- Engaged Lands and Forestry and moved eggs to Hope for Wildlife
- Two other nests were destroyed by the pond side work
- The original plan was to not replace the destroyed nesting site
- Once again working with HRM and L&F, nesting habitat was reconstructed

# Historic interactions with HRM

# Cobequid Road snapping turtle nest destruction and nesting area destruction

- Once again one of our Guardians notified us of the work
- Engaged Lands and Forestry and they refused us permission to investigate the nests.
- Two other nests were destroyed by the pond-side work
- The original plan was to not replace the destroyed nesting site
- Working with HRM crew we were able to get some improved access to the water created for hatchlings.

• We had no recorded instances of Snapping Turtles nesting at this site in 2019.




# Windgate Pond

- The shoulders of Windgate Road beside Windgate Pond were paved this summer.
- In 2018, we had 5 successful nest hatch-outs in the newly paved area.
- While this is not "new" pavement it is re-cycled asphalt – the effect is the same: an impenetrable surface that turtles cannot dig through to lay. If they do actually dig through the material, it is at a significant cost of time, physical effort and exposure to being hit by vehicles.



# Windgate Pond

- These nesting females now need to find another place to nest next year.
- Destruction of snapping turtle nesting habitat is in contravention of the Species at Risk Act (SARA).
- We would very much like to see this type of situation ended.

# Our ask

- We would like to consult with the city so that the "Red Book" can be updated to deal with roadways near wetlands.
- We would like all bank stabilization efforts to employ the one-inch clear aggregate, rather than the larger material, to facilitate hatchlings' ability to get to water.
