Robb, N.S.L.S. dated November 30, 1994, said lot of land being designated as Lot 20, lands claimed by Wendell P. Morris on a Plan of Survey showing Lot 20, Lands Claimed by Wendell P. Morris and Showing Lot 21, Lands Claimed by James Lawton, signed by R. Dale Castle, N.S.L.S. dated October 30, 2004, said Lot 20 having an area of 3,310 square feet, more or less and being more particularly described as follows:
